The documentation submitted from AMCO includes records related to public complaints of odor from this facility. This is also addressed in the Memorandum from the Homer Police Department dated November 15th 2025.

Recommendation:

The Homer City Council may either:

- 1. Approve a letter of non-objection for this renewal application.
- 2. Conditionally protest the renewal application a conditional protest means a means a protest by a local government based on the local government's requirements that the applicant must meet before licensure, and that the applicant has not yet met but that the local government expects the applicant will be able to meet within a reasonable period of time. If the board imposes a condition a government recommends, the local government shall assume responsibility for monitoring compliance with the condition unless the board provides otherwise. (3AAC 306.060)
- 3. Protest the renewal application a local government with jurisdiction over the location of the proposed licensed premises may protest the application by sending the director and the applicant a written protest and the reasons for the protest. The board may, on its own initiative or in response to an objection or protest, hold a hearing to ascertain the reaction of the public or a local government to an application. The director shall send notice of a hearing under this section as provided in AS 44.62.330 44.62.630. (3AAC 306.060 & 070)

Dear Licensee:

After reviewing your renewal documents, AMCO staff has deemed the application complete for the purposes of 3 AAC 306.035(c).

Your application will now be sent electronically, in its entirety, to your local government, your community council (if your proposed premises is in Anchorage or certain locations in the Mat-Su Borough), and to any non-profit agencies who have requested notification of applications. The local government has 60 days to protest your application per 3 AAC 306.060.

At the May 15, 2017 Marijuana Control Board meeting, the board delegated to AMCO Director the authority to approve renewal applications. However, the board is required to consider this application independently if you have been issued any notices of violation for this license, if your local government protests this application, or if a public objection to this application is received within 30 days of this notice under 3 AAC 306.065.

If AMCO staff determines that your application requires independent board consideration for any reason, you will be sent an email notification regarding your mandatory board appearance. Upon final approval, your 2025/2026 license will be provided to you during your annual inspection. If our office determines that an inspection is not necessary, the license will be mailed to you at the mailing address on file for your establishment.

Dear Local Government:

AMCO has received a complete renewal application and/or endorsement renewal application for a marijuana establishment within your jurisdiction. This notice is required under 3 AAC 306.035(c)(2). Application documents will be sent to you separately via ZendTo.

To protest the approval of this application pursuant to 3 AAC 306.060, you must furnish the director and the applicant with a clear and concise written statement of reasons for the protest within 60 days of the date of this notice, and provide AMCO proof of service of the protest upon the applicant.

3 AAC 306.060 states that the board will uphold a local government protest and deny an application for a marijuana establishment license unless the board finds that a protest by a local government is arbitrary, capricious, and unreasonable. If the protest is a "conditional protest" as defined in 3 AAC 306.060(d)(2) and the application otherwise meets all the criteria set forth by the regulations, the Marijuana Control Board may approve the license renewal, but require the applicant to show to the board's satisfaction that the requirements of the local government have been met before the director issues the license.

At the May 15, 2017, Marijuana Control Board meeting, the board delegated to AMCO Director the authority to approve renewal applications with no protests, objections, or notices of violation. However, if a timely protest or objection is filed for this application, or if any notices of violation have been issued for this license, the board will consider the application. In those situations, a temporary license will be issued pending board consideration.

This letter is in response to the *Notice of Violation* (NOV), dated September 19th, 2024, in regard to odor, under 3 AAC 306.430(c)(2) and the two advisory notices that were issued on 03/05/2024 and 06/05/2024.

After receiving the advisory notice from AMCO Enforcement on March 5th, Wildflower Farms performed a ventilation inspection. After determining that there was a defect in one of the Air Handler's, Wildflower Farms ownership took immediate action and installed a variable frequency drive unit (VFD) for Air Handler #3. The installation of the VFD improved the odor situation however, on June 5th, after an additional advisory notice was received, Wildflower Farms performed a second and extreme in-depth ventilation inspection to find that the temperature sensor unit for Air Handler #3 was faulty. Wildflower Farms ownership replaced the temperature sensor in Air Handler #3 which remedied the odor issue.

Wildflower Farms was operating with no odor issues after the VFD and temperature sensor were installed in Air Handler #3 until the date in question.

On the morning of September 19th, a Wildflower Farms employee contacted the licensees and advised the licensees that there was an issue with Air Handler #1. Wildflower Farms licensees immediately contacted a repair person. The repair person arrived at the facility and determined that the sensor on Air Handler #1 had been accidentally bumped causing the sensor to malfunction.

In order to ensure that the sensors are protected and to avoid any repeat occurrence, Wildflower Farms is installing wire cages to encase the control box and have held a meeting with their employees to make them aware of the situation, what effects this issue causes, refresh training on the AMCO regulations regarding odor and how to avoid causing situations like this in the future.

Wildflower Farms understands the importance of being a regulatory compliant licensed facility and takes pride in their cultivation. Wildflower Farms uses carbon filters that are rated to be changed every two years however, the filters have been changed yearly. Wildflower Farms will now change the carbon filters every six months to make 100% sure that they are operating to their maximum efficiency.

Wildflower Farms has been meticulous about ensuring that the facility's variable frequency drive unit (VFD) for Air Handler #3 remains active and efficient. Efforts to improve employee awareness and training on current regulations and compliance have been enforced. Regular maintenance and checks have been performed on the facility's air filtration units. Currently, there are plans to install wire cages around Air Handler #1 in order to protect the sensors from accidental bumps. The company is taking odor control very seriously and will continue to implement safeguards to ensure compliance with AMCO regulations.

On April 22nd, 2025, Wildflower Farms conscientiously worked to ensure all doors remained closed during harvesting. The previous complaints of odor have been linked with the days on which harvesting occurs. The air filters were last changed in October 2024, and new filters are currently being delivered for immediate replacement. Wildflower Farms currently uses carbon filters that are rated to be changed yearly; however, the filters are changed every six months to make absolutely certain that they are operating at maximum efficiency.

Wildflower Farms understands the importance of being a regulatory-compliant licensed facility and takes pride in its cultivation. Every possible step has been taken to ensure that Wildflower Farms does not emit an odor that is detectable by the public. The fine of \$500 will be submitted to AMCO enforcement with the submission of this response. Wildflower Farms is working diligently to solve the issue at hand and eliminate any future complaints of odor.

This letter is in response to the *Notice of Violation* (NOV), dated May 7th, 2025, regarding odor under 3 AAC 306.806(e).

After receiving the AMCO complaint dated April 28th, 2025 (NOV AM25-078), Wildflower Farms submitted its hard-copy response along with the \$500 fee to the AMCO office on May 8, 2025. Since receiving the previous complaint, Wildflower Farms has worked diligently to incorporate safeguards to prevent odor such as ordering the new carbon air filters for replacement, incorporating employee training in current regulations and compliance, ensuring the facilities' Air Handlers remain active and efficient, checking that the doors remain closed to the facility, and confirming that regular maintenance checks are conducted on the facility's air filtration units.

As stated in the previous May 7th, 2025, response, there are plans to install wire cages around Air Handler #1 in order to protect the sensors and make sure the unit is in working condition. The filters that have been ordered are still en route to be delivered for immediate replacement. Ownership has ordered even more filters to be delivered in order to make certain they will be available for the next needed replacement, eliminating the waiting period.

Wildflower Farms understands the importance of being a regulatory-compliant licensed facility and takes pride in its cultivation. Every possible step is being taken to prevent the odor issue from occurring. With the submission of this response, the additional fine of \$500 will be submitted to AMCO enforcement. Dear MCB and Enforcement Team:

This letter is in response to the *Notice of Violation* (NOV), dated June 2nd, 2025, regarding odor under 3 AAC 306.806(e).

Following the receipt of the previous AMCO complaints dated April 28th, 2025 (NOV AM25-0478) and May 7th, 2025 (NOV 25-0530), Wildflower Farms promptly submitted both of its hard-copy responses and two \$500 checks for each of the fees to the AMCO office on May 8th, 2025, and on May 16th, 2025. Wildflower Farms had finally received the new carbon air filters, which had been en route to be delivered for immediate replacement as noted in both previous response letters. All of the old carbon air filters in the facility were changed on June 1st, 2025, on the day the smell was detected.

Inspections of the facility's air circulation units have been conducted, and it has been determined that more expertise is needed to narrow down what is causing the odor. Wildflower Farms is currently in the process of hiring a mechanical engineer to assess the ducting, pressurization, and filtration system of the building. With this taking place, the issue of why Marijuana odor is being detected will be swiftly determined and resolved so that no other complaints arise.

Wildflower Farms will also continue to ensure the doors remain closed to the facility and proper maintenance checks are conducted on the facility's air filtration units. Additional carbon air filters have been ordered to be stored for the next filter change, so that there is no waiting period for the next replacement. Additional measures will be put in place as necessary to ensure the facility is in compliance with the odor regulation. With the submission of this response, the additional \$500 will be submitted to AMCO enforcement.

On November 15th, 2025 I received the attached application for license renewal. The Homer Police Department (HPD) has, not necessarily an objection, but concerns with this renewal.

Alaska Loven It, LLC was issued an advisory notice on June 4th, 2024 and four separate violations of 3AAC 306.430 between September 19th, 2024 and June 1st, 2025.

Additionally, this morning (November 15th, 2025), at approximately 0930 hours, I was on patrol on Kachemak Drive and could smell the odor of fresh marijuana coming from that establishment.

Their last communication from legal, dated June 6th, 2025, advised they would need more expertise on narrowing down the source of odor that neighboring residents and passersby's have complained of.

The Departments concern is that, while they appear to be legitimately attempting to locate and secure the source of emitting odors, they have been unable to do so for over a year, causing issues and complaints from the public.

- (1) the board approved an application for retransfer before the foreclosure; or
- (2) the amount owed to the former licensee for the real property at the time of foreclosure exceeds the fair market value of the property; the former licensee carries the burden of proof to show that the fair market value is less than the amount owed. (Eff. 3/22/2024, Register 249)

3 AAC 306.055. Criminal justice information and records.

- (a) When filing an application for a new marijuana establishment license, transfer of a license to another person, or ownership change, the applicant, including each individual listed in 3 AAC 306.020(b)(2), must submit the person's fingerprints and the fees required by the Department of Public Safety under AS 12.62.160 for criminal justice information. An individual who has submitted fingerprints and fees under this section is not required to submit a new set of fingerprints and fees for a second or subsequent application for a new license, transfer of a marijuana establishment license to another person, or ownership change, if the second or subsequent application is submitted not later than 12 calendar months after the date criminal justice information is received in response to the initial submission of fingerprints and fees.
- (b) The director shall submit the fingerprints to the Department of Public Safety to obtain a report of criminal justice information under AS 12.62. The board will use the information obtained under this section to determine if an applicant is qualified for a marijuana establishment license.
- (c) In this section, "criminal justice information" has the meaning given in AS 12.62.900. (Eff. 2/21/2016, Register 217; am 5/9/2019, Register 230; am 1/22/2023, Register 245)

3 AAC 306.060. Protest by local government.

(a) Not later than 60 days after the director sends notice of an application for a new marijuana establishment license, a new onsite consumption endorsement, renewal of a marijuana establishment license, renewal of an onsite consumption endorsement, license conversion, endorsement, transfer of a marijuana establishment to another person, or transfer of a marijuana establishment license to another location, a local government with jurisdiction over the location of the proposed licensed premises may protest the application by sending the director and the applicant a written protest and the reasons for the protest. If an application for a transfer of a marijuana establishment license to another location proposes to relocate a licensed establishment within the jurisdiction of a different local government, the local government with jurisdiction over

the proposed location may protest the application on the basis of taxes owed to the local government with jurisdiction over the current location of the licensed premises. The director may not accept a protest received after the 60-day period. If the protest is a conditional protest, the board will require the applicant to show, to the board's satisfaction, that the requirements of the local government have been met before the director may issue the marijuana establishment license. If the protest is not a conditional protest, the board will deny the application unless the board finds that the protest is arbitrary, capricious, and unreasonable.

- (b) A local government may recommend that the board approve an application for a new marijuana establishment license, a new onsite consumption endorsement, renewal of a marijuana establishment license, renewal of an onsite consumption endorsement, license conversion, transfer of a marijuana establishment license to another person, or transfer of a marijuana establishment license to another location subject to a condition. If an application for a transfer of a marijuana establishment license to another location proposes to relocate a licensed establishment within the jurisdiction of a different local government, the local government with jurisdiction over the proposed location may recommend that the board approve the marijuana establishment license subject to a condition that is based on reasons identified by the local government with jurisdiction over the current location, of those reasons are still relevant to the proposed location. The board will impose a condition a local government recommends unless the board finds the recommended condition is arbitrary, capricious, and unreasonable. If the board imposes a condition a local government recommends, the local government shall assume responsibility for monitoring compliance with the condition unless the board provides otherwise.
- (c) If a local government with jurisdiction over the location of the licensed premises determines that a marijuana establishment has violated a provision of AS 17.38, this chapter, or a condition the board has imposed on the licensee, the local government may notify the board. Unless the director finds that the local government's notice is arbitrary, capricious, and unreasonable, the director shall prepare the determination as an accusation against the licensee under AS 44.62.360 and conduct proceedings to resolve the matter as provided under 3 AAC 306.820.
 - (d) In this section,
- (1) "local government" means each local government with jurisdiction over the licensed premises; in case of an application for a transfer of a marijuana establishment license to

another location, "local government' means the local government with jurisdiction over the proposed licensed premises;

- (2) "conditional protest" means a protest by a local government based on the local government's requirements that the applicant must meet before licensure, and that the applicant has not yet met but that the local government expects the applicant will be able to meet within a reasonable period of time.
- (e) Not later than 60 days after the director sends notice of an application for a transfer of a marijuana establishment license to another location where the local government would be different, the local government with jurisdiction over the current licensed premises may protest the application upon the basis of taxes owed by the licensee to that local government by sending the director and the applicant a written protest and the reasons for the protest. The director may not accept and the board will not consider a protest received under this subsection after the 60-day period. (Eff. 2/21/2016, Register 217; am 12/28/2017, Register 224; am 2/21/2019, Register 229; am 4/11/2019, Register 230; am 5/9/2019, Register 230; am 1/22/2023, Register 245)

3 AAC 306.065. Public participation.

A person may object to an application for a new marijuana establishment license, renewal of a marijuana establishment license, license conversion, transfer of a marijuana establishment license to another person, or transfer of a marijuana establishment license to another location by submitting a written statement of reasons for the objection to the board and the applicant not later than 30 days after the director has determined that the application is complete and has given written notice to the local government in accordance with 3 AAC 306.025. The objection must be sent to the applicant at the mailing address or electronic mail address provided in the notice of application and also to the board. If the board determines to conduct a public hearing under this section, an interested person may give oral testimony at the public hearing. (Eff. 2/21/2016, Register 217; am 12/28/2017, Register 224; am 2/21/2019, Register 229)

3 AAC 306.070. Hearing on public protest.

The board may, on its own initiative or in response to an objection or protest, hold a hearing to

ascertain the reaction of the public or a local government to an application. The director shall send notice of a hearing under this section as provided in AS 44.62.330 - 44.62.630 (Administrative Procedure Act). (Eff. 2/21/2016, Register 217)

3 AAC 306.075. Procedure for action on license application.

- (a) The board will decide whether to grant or deny an application for a marijuana establishment license not later than 90 days after receiving the complete application. However, the board will not grant or deny the application before the time allowed for a protest under 3 AAC 306.060, unless the local government waives its right to protest.
- (b) Not later than seven days before the date set for board action on applications, the director shall post a meeting agenda listing the matters scheduled for action at that meeting. The board may review an application without additional notice to the applicant.
- (c) The board will consider any written objection, protest, suggested condition, or petition, and also will consider any testimony received at a hearing on public protest held under 3 AAC 306.070 when it considers the application. The director shall retain the written objection, protest, or suggested condition or petition, and the hearing record as part of the permanent record of the board's review of an application. (Eff. 2/21/2016, Register 217; am 12/28/2017, Register 224; am 2/21/2019, Register 229; am 1/22/2023, Register 245)

3 AAC 306.080. Denial of license or endorsement application.

- (a) After review of the application, including the applicant's proposed operating plan and all relevant information, the board will deny an application for a new license or new onsite consumption endorsement if the board finds that
- (1) the application is not complete as required under the applicable provisions of 3 AAC 306.020 3 AAC 306.055, or contains any false statement of material fact;
- (2) the license or endorsement would violate any restriction in 3 AAC 306.010 or 3 AAC 306.015;
- (3) the license or endorsement would violate any restriction applicable to the particular license type authorized under this chapter;
- (4) the license or endorsement is prohibited under this chapter as a result of a ordinance or election conducted under AS 14.38.210, 3 AAC 306.200, or 3 AAC 306.230;
- (5) the applicant's actions or the operating plan does not adequately demonstrate that the applicant will comply with applicable provisions of this chapter;
