HCC 1.16.040, Disposition of Scheduled Offenses—Fine Schedule, is adopted 23 to read as follows: 24 25 1.16.040 Disposition of Scheduled Offenses—Fine Schedule. (a) A person cited for an offense for which a fine is established in subsection (c) of this 26 27 section may mail or personally deliver to the Finance Director the amount of the fine indicated on the citation for the offense plus any surcharge required to be imposed by AS 29.25.074, 28 together with a copy of the citation signed by the person indicating the person's waiver of court 29 appearance, entry of plea of no contest, and forfeiture of the fine. A citation for a scheduled 30 31 offense may be mailed or personally delivered within fifteen (15) days after the date of the citation. The payment of a fine under this subsection shall be treated as a judgment of conviction. 32 The fine paid is complete satisfaction for the offense. 33 (b) If a person cited for an offense for which a fine amount is established in subsection 34 (c) of this section appears in court to contest the citation and is found guilty, the maximum 35 sentence which may be imposed is the scheduled fine amount plus any surcharge required to be 36 imposed by AS 29.25.074. 37 38 (c) The following violations of this code are amenable to disposition without court 39 appearance upon payment of a fine in the amount listed below. 40 **CODE SECTION DESCRIPTION OF OFFENSE FINE**

In this chapter: 56 "Camp" means using an outdoor area or motor vehicle for sleeping or temporary living 57 quarters, including without limitation erecting a tent or other temporary shelter. 58 "Park" means an area designated as a park, reservation, playground, beach, recreation 59 area, owned or managed by the city and devoted to active or passive recreation. 60 61 19.20.020 General Rules. The following general rules govern the public use of parks: 62 a. No person may deface, disfigure, damage, tamper with, or displace or remove, any 63 building, structure, table, bench, fireplace, sign, notice, vegetation, or placard in a park. 64 b. No person may cut, pick or damage trees, flowers or other vegetation in a park. 65 c. No person may camp in a park except in an area and at a time designated for that 66 purpose by the city manager. 67 d. No person may light, build, use or maintain an open fire or portable camp stove in a 68 park except in a receptacle or area designated for that use. No person may leave an open fire or 69 operating portable camp stove unattended. No person may use a flammable liquid other than 70 charcoal lighting fluid to start or accelerate a fire. 71 e. No person may operate, or stop, stand or park, a motorized vehicle in a park except: 72 1. In an area designed for the use, and in a manner permitted by the designation; 73 74 or 2. Construction, enforcement, maintenance or emergency vehicles operated by 75 the state, the Kenai Peninsula Borough, the city or their respective contractors. 76 i. Where the operation of motor vehicles is permitted in a park, motor vehicles shall be 77 operated in accordance with posted speed limits, in a prudent and safe manner, and at a speed not 78 exceeding ten (10) miles per hour in parking areas. 79 j. A person having control or supervision of an animal that excretes feces in a park shall 80 immediately collect and properly dispose of the feces. 81 k. No person may dump, deposit, or leave any bottles, broken glass, ashes, paper, boxes, 82 cans, dirt, rubbish, waste, garbage or refuse, or other trash, or water, sewage or effluent from 83 sinks, portable toilets or other plumbing fixtures, directly upon the surface of land or water in a 84 85 park. 1. Dumpsters provided at park facilities are intended for park use only. 86 87 19.20.030 Park Closure. 88 a. The city manager may designate times during which a park is closed to the public.

b. The city manager shall notify the public of times during which a park is closed to the public by the placement of signs at entrances to the park or within the closed area. No person may enter or remain in a park during the hours of closure designated on such a sign.

## 19.20.040 Park Use Agreements.

The council by resolution may authorize an agreement between the city and an organization providing for the organization's use, operation and maintenance of facilities within a park. The agreement will address such issues as scheduling, litter, sanitary facilities, damage, crowd control, traffic control, noise, insurance and public notice.

## 19.20.050 Campground Host Program.

The council by resolution may authorize the city manager to establish a campground host program for designated city parks, under which volunteers will provide campground host services to park users.

## 19.20.060 Regulations.

The city manager is authorized to promulgate regulations, in addition to the rules stated in this chapter, to regulate the use of park and recreational facilities.

## 19.20.070 Remedies and Penalties.

Remedies and penalties for violations of this chapter are as provided in Chapter 1.16.

Section 3. This Ordinance is of a permanent and general character and shall be included in the City Code.
