16	September 10, 2016, sent to two in-state and one Washington state plans rooms, and posted on the Clerk's home page; and

18	WHEREAS, Bids were due on September 22, 2016 and three bids were received; one
19	bid was considered non-responsive; and
20	sta was constacted from responsive, and
21	WHEREAS, Public Works ruled that the bid by Steiner's North Star Construction, Inc.
22	was unresponsive and a protest was filed by the low bidder, and the City Attorney
23	recommends denial of the protest; and

25	WHEREAS, Puffin Electric, Inc. of Homer, Alaska, was found to be the lowest
26	responsive bidder.

28	WHEREAS, The work is funded by a Homeland Security grant and the low bid is within
29	the project budget approved by the grant agency and the City Council; and

31	WHEREAS, This award is not final until written notification is received by the firm from
32	the City of Homer.

34	NOW, THEREFORE, BE IT RESOLVED that the City Council of Homer, Alaska, rejects the
35	protest filed by Steiner's North Star Construction, Inc., and awards the contract for the Homer
36	Library Emergency Generator Installation to the firm of Puffin Electric, Inc. of Homer, Alaska,
37	in the amount of \$31,550.00, and authorizes the City Manager to execute the appropriate
38	documents necessary to complete this work.
