6 A RESOLUTION OF THE HOMER CITY COUNCIL AMENDING A  
7 JOINT AGREEMENT BETWEEN THE CITY OF HOMER AND GLOBAL  
8 SUSTAINABLE FISHERIES OF ALASKA (GSFA) FOR THE PURPOSES  
9 OF GSFA OBTAINING A GRANT FROM THE U.S. DEPARTMENT OF  
10 COMMERCE AND ECONOMIC DEVELOPMENT ADMINISTRATION  
11 (EDA) FOR PROJECT FUNDS FOR ESTABLISHING A SUSTAINABLE  
12 SEAFOOD PROCESSING INDUSTRY WITHIN THE CITY OF HOMER.  
13

14 WHEREAS, On September 12, 2016 Homer City Council passed Resolution 16-096  
15 approving a Joint Agreement between Global Sustainable Seafoods of Alaska (GSFA) and the  
16 City of Homer for an Economic Adjustment Program grant in the amount of \$1.6 million from  
17 the U.S. Department of Commerce and Economic Development Administration (EDA) to build  
18 a fish processing facility and, using flash-freezing technology, will export frozen fish to Japan  
19 and the Lower 48; and

21 WHEREAS, EDA has requested an amendment to the Joint Agreement to reflect only  
22 the square footage of the building funded by the EDA grant and the fact that the building will  
23 be on a concrete foundation; and

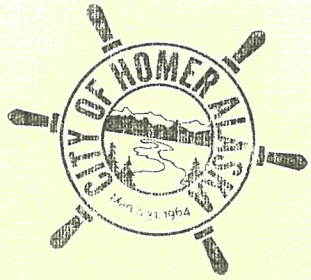
25 WHEREAS, Version 2 of the Joint Agreement makes the following change to the Joint  
26 Agreement Part 3: "GSFA will be responsible for bidding, award, and management of  
27 constructing a building, estimated at 2,600 to 2,700 sf, on a concrete foundation for a single-  
28 story fish process facility"; and

30 WHEREAS, These changes are necessary for GSFA to be able to proceed with the  
31 granting agency; and

33 NOW, THEREFORE, BE IT RESOLVED that the City Council of Homer, Alaska, approves  
34 the attached amended Joint Agreement between the City of Homer and Global Sustainable  
35 Fisheries of Alaska (Version 2).
