ON LEASE NEGOTIATIONS 12 AND EXECUTE THE APPROPRIATE DOCUMENTS. 13 14 WHEREAS, Ordinance 16-53 authorized the City Manager and CityScape Consultants, 15 16 Inc. to facilitate lease negotiations for a long-term communication tower lease and contract on 17 Lot 11, Homer Spit Subdivision No. 5, including the request for proposal, selection process and sitting of the tower and equipment; and 18 19 20 WHEREAS, A Request for Proposals for a Wireless Communication Tower for Homer Spit 21 Property was issued on December 9, 2016; and 22 23 WHEREAS, The advertisement for sealed proposals for a Wireless Communication 24 Tower for Homer Spit Property was advertised in the Homer Tribune on December 15 and 22, 2016, the Anchorage Daily News on December 18 and 24, 2016, and posted on the Alaska Bid 25 26 Network: and 27 WHEREAS, Sealed proposals were due at the Office of the City Clerk by 4:00 p.m. on 28 January 17, 2017; and 29 30 WHEREAS, Three proposals were submitted and reviewed by CityScape Consultants. 31 32 Inc. who determined Wireless Edge Towers, LLC as the highest ranked candidate and 33 recommends going into negotiations for 30 days regarding the terms of the lease; and 34 WHEREAS, CityScape Consultants, Inc. further recommends if terms cannot be reached 35 36 in the 30-day negotiation period they will work with the next ranked candidate, Atlas Tower Holdings, LLC. 37 38 NOW, THEREFORE, BE IT RESOLVED that the Homer City Council hereby approves a new 39 ten-year lease with four ten-year renewal terms with Wireless Edge Towers, LLC of New 40

Rochelle, New York, and authorizes the City Manager and CityScape Consultants, Inc. to

negotiate and execute the appropriate documents.
