WHEREAS, In compliance with Homer City Code 4.35, the Canvass Board of the City of Homer has opened, counted, and tallied the votes on absentee ballots including special needs ballots, and question ballots found to be valid, that were cast in the City of Homer Special Election held on June 13, 2017; and

WHEREAS, The total number of voters voting in the City Special Election was 1992 and reflects the number of voters, not the number of votes cast or ballots counted; and

WHEREAS, In accordance with Homer City Code 4.35, the Canvass Board of the City of Homer had inspected the prescient reports, Election Central Logs and entered the the results of the absent and questioned ballots on the Certification of Election along with the results of the precinct counts; and

WHEREAS, The results of the Special City Election held June 13, 2017, attached as Exhibit A, is presented in the Canvass Board's Certificate of Election in accordance with the Homer City Code.





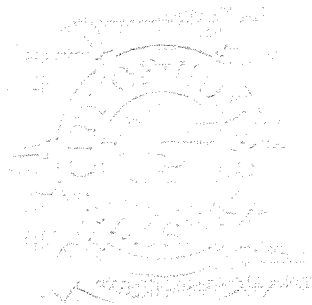
