HCC 7.06.020 Use of improperly muffled engine brakes prohibited is hereby amended to read as follows: 22 23 7.06.020 Use of improperly muffled engine brakes prohibited. 24 25 a. The use of muffled engine brakes is prohibited within the City except when 26 traveling downhill on the Sterling Highway from Milepost 169 to 173, Main Street, 27 East Hill Road and West Hill Road. 28 29 ba. Muffled engine brakes may only be used under this section if No person may use 30 engine brakes while operating a motor vehicle within the City, unless the vehicle is 31 equipped with a muffler or other effective noise-suppressing system in good working 32 order and in constant operation, with no cutout, bypass, or similar device. For the 33 purpose of this section, the term "engine brake" means a hydraulic engine attachment 34 which converts a diesel engine into an air compressor and when engaged operates to 35 slow the vehicle. 36 37 bc. The police chief shall adopt procedures for the provision of commercial vehicle 38 inspections for repeat violators. For the purpose of this section, the term "engine 39 brake" means a hydraulic engine attachment which converts a diesel engine into 40 an air compressor and when engaged operates to slow the vehicle. 41 42
