WHEREAS, Due to the outbreak of COVID-19 novel coronavirus, a contagious virus that is spread mainly person to person, nonessential services are closing down and communities are implementing continuity of operations plans to enable ongoing essential operations; and WHEREAS, Homer City Code 2.08.110(c) requires that four members present must vote to allow other members to participate telephonically; and WHEREAS, In the event it becomes necessary to stand down normal operations of the City of Homer, the Homer City Council will need to have the ability to meet to make necessary decisions on behalf of the City. NOW THEREFORE, THE CITY OF HOMER ORDAINS: Section 1. The Homer City Council may convene all members telephonically or web-**hosted** for a meeting that has been properly noticed pursuant to HCC 1.14. Section 2. The City of Homer will work in conjunction with local radio, and telephone and internet providers to make the meeting available by broadcast and accommodate public comments through electronic means. Section 3. This is an emergency ordinance of general character and will be effective for 60 days, in accordance with HCC 1.08.040.
