19	WHEREAS, The municipality's role is to insure a smooth transition through responsible
20	implementation of new laws; and
21	WILLEDEAS Many municipalities provide an effective data that reasonably allows for

25	WHEREAS, The effective date of the bag ban did not allow for seasonal businesses to

operations, or February 14 September 15, 2020, whichever comes first.
