Notwithstanding anything to the contrary in Homer City Code Chapter 15.10 29 regarding the use of tax revenues levied and collected in the Ocean Loop Drive Special Service 30 District, the Homer City Council hereby amends the FY 2010 Operating Budget by appropriating 31 \$11,650.00 from the Ocean Drive Loop Special Service District for the purpose of paying the 32 33 cost of repairs to the seawall as follows: 34 35 Revenue: Account Number 36 Description Amount 37 156-369 Seawall Reserve Account \$11,650.00 38 Expenditure: 39 Account Number 40 Description Amount 808-375 41 Ocean Drive Loop \$11,650.00 42 Special Service District

Section 2. Notwithstanding anything to the contrary in Homer City Code Chapter 15.10

regarding the use of tax revenues levied and collected in the Ocean Loop Drive Special Service

District, the Homer City Council hereby amends the FY 2010 Operating Budget by appropriating

Section 3. The City shall pay a portion of the amount appropriated by Section 2 to each person who paid real property taxes in the Ocean Drive Loop Special Service District, ("Taxpayer") with the amount of the payment to each Taxpayer being determined *pro rata* based on the portion of the total amount of taxes levied and collected in the Ocean Drive Loop Special Service District that was paid by that Taxpayer.

Section 4. This ordinance shall take effect upon its adoption by the Homer City Council.

Section 5. This is a budget amendment ordinance, is temporary in nature, and shall not be codified.
