6 AN ORDINANCE OF THE CITY COUNCIL OF HOMER,
7 ALASKA, AMENDING THE FY 2012 OPERATING BUDGET
8 BY APPROPRIATING AND TRANSFERRING \$81,000 FROM
9 THE GENERAL FUND RESERVE (FUND BALANCE) TO THE
10 CITY HALL COMPLEX BUDGET FOR THE PURPOSE OF
11 ACQUIRING NEW FURNITURE AT CITY HALL.

13 WHEREAS, The City Hall expansion and renovation project is essentially complete and
14 the project budget contained funds for furniture in the Council Chambers and other public areas;
15 and

16 WHEREAS, There are two public areas which still need to be furnished and several
17 office spaces where the old furniture should be replaced.

19 NOW, THEREFORE, THE CITY OF HOMER ORDAINS:

21 Section 1. The Homer City Council hereby amends the FY 2012 Operating Budget by
22 appropriating and transferring \$81,000 from the General Fund Reserve (Fund Balance) to the
23 City Hall Complex operating budget as follows:
