6 AN ORDINANCE OF THE CITY COUNCIL OF HOMER, ALASKA,
7 AMENDING THE FY 2015 OPERATING BUDGET BY AUTHORIZING
8 THE EXPENDITURE OF \$150,000 FOR THE PURCHASE OF A DUMP
9 TRUCK FROM THE GENERAL FUND, AUTHORIZING THE
10 APPLICATION OF A LOAN FOR SAID PURCHASE, AND
11 AUTHORIZING THE CITY MANAGER TO EXECUTE ALL
12 APPROPRIATE DOCUMENTS.
13

14 WHEREAS, One of the two Public Works dump trucks has been taken out of service due
15 to extensive frame damage making it cost prohibitive to repair; and
16

17 WHEREAS, It is necessary to have two in the work fleet as they are often used
18 simultaneously and to have one available when the other is down for repairs or maintenance;
19 and
20

21 WHEREAS, Public Works can utilize the State's purchase contract and recognize a
22 \$27,000 savings from the normal retail price for the same truck; and

24 WHEREAS, Public Works has looked at used trucks and finds that the age and cost to
25 outfit it to serve their needs makes a new truck purchased through the State contract a
26 preferred option.

28 NOW, THEREFORE, THE CITY OF HOMER ORDAINS:
29

30 Section 1. The Homer City Council hereby amends the FY 2015 Operating Budget by
31 appropriating \$150,000 from the Public Works Vehicle Depreciation Fund for the purchase of
32 a new dump truck.

38 Section 2. The Homer City Council hereby authorizes the City Manager to apply for and
39 secure a 2.833% loan (through Construction Machinery Inc.) in the amount of \$150,000 for the
40 dump truck purchase for the term of 60 months.

42 Section 3. This is a budget amendment ordinance only, is not permanent in nature,
43 and shall not be codified.
