(Northern Enterprises) is a Homerbased corporation specializing in vessel haul out, repair, and storage; and 15 16 17 WHEREAS, Northern Enterprises entered into a 20 year lease with the City on May 1 2019 for 60 square feet of tidelands to accommodate their construction of a new dock capable of 18 supporting a Marine Travel Lift Station to haul out larger, heavier vessels in deeper waters; and 19 20 WHEREAS, Northern Enterprises was informed by their financial lenders that, per Alaska 21 Admin Code 3AAC 99.230, they are required to have a set term of lease that covers 10 years 22 beyond the timeframe of the loans; and 23 24 25 WHEREAS, Northern Enterprises is requesting an amendment to the lease to extend the original term from 20 years with options for 2 consecutive 5 year renewals to 40 years with 2 26 consecutive 5 year renewals, giving a new final end date of April 30 2059; and 27 28 WHEREAS, No other neighboring upland businesses with a similar competing interest 29 abut City tidelands parcel ATS 612; and 30 31 WHEREAS, On October 20 2020, the Port and Harbor Advisory Commission discussed 32 the proposed change in term for the Northern Enterprises lease of City tidelands parcel ATS 33 612 and passed a motion, with unanimous consent, to recommend that City Council approve 34 the amendment of the Northern Enterprises' lease to extend the term to 40 years with options 35 for 2 consecutive 5 year renewals; and 36 37 WHEREAS, HCC 18.08.160(e) States that any significant changes in the terms (use) of the 38 existing lease must be reviewed by the Port and Harbor Commission and approved by City 39

Council by resolution as an amendment to the lease; and
