21 22	kiosk and is thus, the only source available for this technology, and
23	WHEREAS, T2 Systems has submitted a quote in the amount of \$56,274 for the
24	hardware, which City staff has determined to be fair and reasonable; and

26	WHEREAS, Shipping and installation costs are still pending; and

28	WHEREAS, The City Manager is authorized, per HCC 3.16.060, to execute exemptions to
