16	light fixtures; and

18	WHEREAS, In the course of installing the LED fixtures in the Waste Water Treatment				
19	Plant (WWTP), it was discovered that 29 of the light fixtures are badly damaged from the highly				
20	corrosive environment in the WWTP, which means the fixtures, and some associated wiring,				
21	needs to be replaced completely; and

23	WHEREAS, the extra cost for this replacement work is \$17,148, as a change order to the				
24	purchase order issued to local contractor, Liberty Electric, Inc.

26	NOW, THEREFORE, the City Council of Homer ordains:

28	Section 1. That Ordinance 20-92 be amended to appropriate an additional \$17,148,				
29	from the Sewer Reserve Fund, for a total appropriation of \$35,844 to retrofit high energy light				
30	fixtures at the Sewer Treatment Plant Campus with low energy LED fixtures.
