6 A RESOLUTION OF THE CITY COUNCIL OF HOMER, ALASKA,  
7 AMENDING THE CITY OF HOMER FEE SCHEDULE UNDER CITY  
8 CLERKS, HOMER POLICE DEPARTMENT, LIBRARY, AND PLANNING  
9 AND ZONING.

11 WHEREAS, Ordinance 22-14 amends Homer City Code related to Special Event and  
12 Fireworks permits; and

13  
14 WHEREAS, Ordinance 22-15 amends Homer City Code related to Mobile Food Service;  
15 and

16  
17 WHEREAS, Memorandum 22-039 recommends removing the requirement to obtain a  
18 fireworks permit from the City Clerk's office and file a bond with the City; and

19  
20 WHEREAS, Memorandum 22-041 outlines the proposed cost for a Mobile Food Service  
21 Permit, reducing it from \$390 to \$50, and recommends removing it from the Police Department  
22 fee schedule and adding it in the Planning and Zoning section of the City Fee Schedule; and

24 WHEREAS, At their March 15<sup>th</sup> Regular Meeting the Library Advisory Board approved an  
25 increase in copy fees for the purpose of covering the cost of this service provided by the Library.

27 NOW, THEREFORE, BE IT RESOLVED that the City Council of Homer, Alaska, hereby  
28 amends the City Fee Schedule under City Clerks, Homer Police Department, and Planning and  
29 Zoning as follows:




