CITY OF HOMER 1 2 HOMER, ALASKA 3 City Manager/Port Director 4 **RESOLUTION 23-058** 5 6 A RESOLUTION OF THE CITY COUNCIL OF HOMER, ALASKA, 7 EXPRESSING SUPPORT FOR AND ADOPTING THE 8 HOMER HARBOR EXPANSION CHARTER. 9 10 WHEREAS, Improvements to Homer's harbor infrastructure holds significant 11 opportunities for ensuring Homer's maritime economic future and regional food security, 12 educational and scientific research opportunities, green infrastructure utilization, and general 13 navigational safety upgrades for all users; and 14 15 WHEREAS, On March 29, 2023 the City of Homer entered into an agreement with the US 16 Army Corps of Engineers to engage in a three-year general investigation study that will complete and provide the economic, environmental, geophysical and engineering analysis of 17 18 design solutions to determine Federal interest in a Homer Harbor Expansion project; and 19 20 WHEREAS, As part of the general investigation study, the City of Homer will develop alternatives and refine a plan for providing local services facilities (facilities needed to attain 21 22 the benefits of the project like floats and necessary onshore equipment) in step with the US 23 Army Corps of Engineers study timeline and milestones; and 24 25 WHEREAS, Careful planning and outlining community goals will benefit these actions 26 and help advance the study in a way that best serves the entire Homer community; and 27 28 WHEREAS, On April 28, 2023 the Homer City Council, Port and Harbor Advisory 29 Commission, and City staff met in a joint worksession to collectively review and reach agreement on a Homer Harbor Expansion Charter to align leadership, direction, and serve as a foundation 30 for guiding decisions as the study advances; and 31 32 33 WHEREAS, The Charter defines a shared vision, collective goals and objectives, and 34 success factors for the City's role in the Homer Harbor Expansion; and 35 36 WHEREAS, The final draft of the Charter was reviewed by the Port and Harbor Advisory 37 Commission at their May 24, 2023 meeting where the Commission unanimously approved a 38 motion recommending that City Council support and approve the Charter. 39 40 NOW, THEREFORE, BE IT RESOLVED that the City Council of Homer, Alaska hereby 41 supports and adopts the Homer Harbor Expansion Charter. 42 43 PASSED AND ADOPTED by the Homer City Council this 12<sup>th</sup> day of June, 2023.
