1 CITY OF HOMER 2 HOMER, ALASKA 3 City Manager 4 **RESOLUTION 24-011** 5 6 A RESOLUTION OF THE CITY COUNCIL OF HOMER, ALASKA 7 APPROVING A SOLE SOURCE CONTRACT IN THE AMOUNT OF \$195,000 TO COMFORTS OF HOME SERVICES TO PURCHASE 8 9 THREE MOBILE RESTROOMS AUTHORIZING THE CITY MANAGER 10 TO NEGOTIATE AND EXECUTE THE APPROPRIATE DOCUMENTS. 11 12 WHEREAS, Public Work's staff has conducted research on the feasibility of purchasing 13 mobile restrooms and has concluded they would be appropriate and beneficial for use in several Homer parks; and 14 15 16 WHEREAS, Two companies were found to have mobile restrooms, ATCO and Comforts 17 of Home, and Comforts of Home was found to be the only one to provide ADA-compliant units; 18 and 19 WHEREAS, Comforts of Home quoted a price of \$60,666.75 per unit, including shipping 20 to Fife, Washington, with each unit comprised of three stalls, one of which would be ADA-21 22 compliant, and available for delivery and set up no later than mid-summer 2024; and 23 24 WHEREAS, Homer City Code allows exceptions to be made to bidding requirements in 25 the cases where a sole source procurements is justified, HCC 3.16.060(i); and 26 27 WHEREAS, A sole source procurement is justified in this case because Comforts of Homer is the only vendor we've found that provides mobile restroom for general, ADA-28 29 compliant public use; and 30 31 WHEREAS, Comforts of Home's cost proposal is deemed fair and reasonable, as it will 32 provide for a bathroom with running water and flushable toilets at one of our busiest parks for 33 less than the cost estimated to build the concrete slab for the brick/mortar restroom that was planned; and 34 35 36 WHEREAS, At its November 16, 2023, regular meeting, the Parks, Art, Recreation and Culture Advisory Commission ("PARCAC") reviewed the proposal for mobile restrooms and 37 38 recommended their use for Jack Gist Park and Karen Hornaday Park; and 39

WHEREAS, This contract is contingent on the adoption of Ordinances 24-03 and 24-04.
