7 A RESOLUTION OF THE CITY COUNCIL OF HOMER, ALASKA  
8 SUPPORTING THE STATE OF ALASKA'S CONTINUED  
9 PARTNERSHIP IN THE US CORPS OF ENGINEERS HOMER HARBOR  
10 EXPANSION GENERAL INVESTIGATION AND REQUESTING  
11 ADDITIONAL LOCAL SPONSOR MATCH FUNDING IN FY25 IN THE  
12 AMOUNT OF \$288,523, CONSISTENT WITH THE SHARED LOCAL  
13 MATCH PARTNERSHIP ESTABLISHED IN 2023.  
14

15 WHEREAS, Homer's Port & Harbor, originally built in 1963, is a regional port serving the  
16 needs of commercial vessels operating throughout Southcentral and western Alaska, and the  
17 Arctic in the marine transportation, maritime industrial and commercial fishing industries; and  
18

19 WHEREAS, Over time, the increased demand for moorage has outgrown Homer Port  
20 and Harbor's ability to safely and efficiently serve this fleet; and  
21

22 WHEREAS, The City of Homer ("City") has identified a new large vessel harbor expansion  
23 among its highest ranked priority capital improvement projects since 2004 to (1) meet the  
24 growing needs of our commercial fleet, (2) address overcrowding and associated navigational  
25 safety concerns and high maintenance costs, and (3) support current as well as emerging  
26 regional and national economic opportunities; and  
27

28 WHEREAS, The Homer Harbor Expansion's General Investigation (GI) with the US Army  
29 Corps of Engineers (USACE) was successfully initiated in 2023 under a \$3 million Federal Cost  
30 Share Agreement in which the federal match is fifty percent and the fifty percent local sponsor  
31 match is shared equally between the City and the State of Alaska; and  
32

33 WHEREAS, Homer City Council is greatly appreciative of the involvement and  
34 investment of our Federal and State partners to move this important project forward; and  
35

36 WHEREAS, The GI investigates all planning aspects needed to build a large vessel harbor  
37 at the Homer Spit including, but not limited to: selecting a preferred design alternative and  
38 construction methods, evaluating social, economic and environmental factors, determining  
39 costs and conducting a cost benefit analysis, which is required to determine Federal interest  
40 in continuing to Project Engineering and Design and Construction phases; and  
41

42 WHEREAS, After reaching the study's Alternatives and Measures Milestone, the USACE  
43 project development team updated the project management plan (PMP) to include two

44 additional activities in the GI scope (geotechnical analysis and ship simulation) so that the  
45 study would have sufficient data to develop the most realistic benefit to cost ratio; and

46  
47 WHEREAS, Based on a cost estimate provided by the USACE, this additional work comes  
48 with an additional cost of \$1,154,093; and

49  
50 WHEREAS, Homer City Council Resolution 23-130 agreed to the revised scope and cost  
51 of the GI under the PMP, stating it is prudent to continue to explore options for a harbor  
52 expansion to relieve congestion and improve navigational safety within Homer's Port and  
53 Harbor; and



55 WHEREAS, Consistent with the shared local match partnership, Homer City Council  
56 Resolution 23-130 additionally expressed the City of Homer's intent to appropriate funds in the  
57 amount of \$288,524 for fifty percent of the required local sponsor match via Ordinance 24-05  
58 at the January 22, 2024 Homer City Council meeting; and

59  
60 WHEREAS, The success and continuation of this project lies in continued active  
61 partnership and investment at the local, state and federal levels.

63 NOW THEREFORE BE IT RESOLVED that the City Council of Homer, Alaska hereby  
64 supports the State of Alaska's continued partnership in the USACE Homer Harbor Expansion  
65 General Investigation and requests additional State match funding in the amount of \$288,523,  
66 consistent with the shared local match partnership established in 2023.


