ORDINANCE 24-57

AN EMERGENCY ORDINANCE OF THE CITY COUNCIL OF HOMER,
ALASKA APPROPRIATING \$60,000 FROM GENERAL FUND CAPITAL
ASSET REPAIR AND MAINTENANCE (CARMA) FUND FOR THE
PURPOSE OF REPAIRING SEWER LINES AT THE HOMER
VOLUNTEER FIRE DEPARTMENT.

WHEREAS, On Saturday, October 19, 2024 Fire Chief Kirko reported sewage back up at
the Homer Volunteer Fire Department (HVFD) Building and sewage coming up into the
emergency vehicle bays; and

WHEREAS, A contractor from Kachemak Pro Flow was able to respond and clear the
pipe; and

WHEREAS, On Friday, October 25, 2024 the contractor sent a camera down into the
plumbing and found broken piping with rocks in the pipe causing the backup; and

WHEREAS, The sewage is backing up through the drains again today; and

WHEREAS, It is imperative we take steps to resolve this sewage issue as we have 24 hour
staffing onsite at the HFVD to respond to emergencies; and

WHEREAS, It is a health and safety issue to have staff and volunteers in a building with
sewage backing up into the building; and

WHEREAS, Investment income associated with the General Fund is pooled into the
General Fund CARMA per HCC 3.10.105 and is recorded to the General CARMA subaccount on a
monthly basis.

WHEREAS, Per HCC 1.08.040 emergency ordinances are valid for 60 days.

NOW THEREFORE, THE CITY OF HOMER ORDAINS:

Section 1. The Homer City Council hereby amends the FY25 Capital Budget by
transferring \$30,000 within the General Fund CARMA as follows:

Transfer from:

Section 3. This is an emergency ordinance of general character and will be effective for 60 days, in accordance with HCC 1.08.040.




