APPROVING A CONTRACT TO MACSWAIN APPRAISALS, LLC 8 IN THE AMOUNT OF \$12,000 TO PROVIDE APPRAISAL 9 SERVICES TO SUPPORT THE KACHEMAK PEATLANDS 10 PROJECT AND AUTHORIZING THE CITY MANAGER TO 11 12 NEGOTIATE AND EXECUTE THE **APPROPRIATE** DOCUMENTS. 13 14 15 WHEREAS, The City Council included funds in the FY25 Capital Budget to support the Kachemak Peatlands Green Infrastructure Storm Water Management Project; and 16 17 WHEREAS, The City has a grant from NOAA, through the Kachemak Bay National 18 19 Estuarine Research Reserve (KBNERR) which could be used to acquire peatlands to be preserved in conservation and used as part of the Kachemak Sponge wetland treatment 20 system; and 21 22 23 WHEREAS, In order to acquire the wetlands with federal funds, we need appraisals that 24 comply with the Uniform Appraisal Standards for Federal Land Acquisition (UASFLA), which are 25 more stringent than the typically used Uniform Standards of Professional Appraisal Practice 26 (USPAP); and 27 WHEREAS, MacSwain Associates, LLC, ("MacSwain") of Anchorage, Alaska has the 28 29 necessary credentials and produced the appraisals that supported the NOAA grant application; 30 and WHEREAS, MacSwain submitted a proposal to provide a new appraisal for the total 31 contract value not to exceed \$12,000; and 32 33 WHEREAS, This award is not final until written notification is received by the firm from 34 the City of Homer. 35 36 NOW, THEREFORE, BE IT RESOLVED that the City Council of Homer, Alaska, approves a 37 contract for professional real estate appraisal services to MacSwain Associates LLC of 38 Anchorage, Alaska and authorizes the City Manager to negotiate and execute the appropriate 39
