10.04.085 Use of Load and Launch Ramp

- (a) Terms and conditions for use of the Small Boat Harbor load and launch ramp are provided in the Homer port and harbor tariff as amended from time to time.
- (b) No person who is obligated to pay a fee for using the Small Boat Harbor load and launch ramp may use the Small Boat Harbor load and launch ramp without first paying the fee prescribed for its use.
- (c) A person who is obligated to pay a fee for using the Small Boat Harbor load and launch ramp must make the ticket verifying payment available upon request, or display the seasonal permit on the port side of the permit holder's vessel.

<u>Section 3</u>. This ordinance shall take effect upon its adoption by the Homer City Council.
