Adele Person, city resident, commented on safe routes to school and trail connectivity.

A. Staff Report - Julie Engebretsen, Deputy City Planner

Ms. Engebretsen was not in attendance.

B. Parks Maintenance - Angie Otteson

Ms. Otteson was not in attendance.

C. Community Recreation - Mike Illg

Mr. Illg reported that he attended a meeting on establishing a folk school in Homer, very interesting; there are many new classes being offered this summer; Hersey Track & Field event is this weekend; the Homer track will be closed this summer for installation of the artificial turf; they are doing the final draft on the trails map and it should be ready for distribution early June.

D. PARC Status Update Report - Matt Steffy

Ms. Krause provided a status update on receipt of five proposals one from Colorado and one from North Carolina. She reported that Ms. Engebretsen was very happy to receive so many submittals. It was hoped for three four would be great and we received five. So it is all good. She was unable to report when a decision would be forthcoming from the committee.

## **PUBLIC HEARING**

There were none.

### PENDING BUSINESS

A. Traffic Calming and Safety Measures in Karen Hornaday Park

The commissioners discussed the feasibility of installing speed bumps on the entrance road into the park, crosswalks, and signage. Mr. Meyer explained that Planning Staff was working on a policy for speed bumps.

Discussion continued on the various alternatives to stop the speeders - installation of signage, accommodating pedestrians from Fairview into the park and adequate parking for any visitors and residents to the park. Vice Chair Brann encouraged the commissioners to research inexpensive traffic calming measures that can get this accomplished in short time and bring the information to the June meeting.

The commissioners requested flyers that state the following to be put on vehicle windshields since the baseball games will be starting the week of May 20, 2014. The flyer will read:

PLEASE FOR THE SAFETY OF OUR CHILDREN AND OTHER PEDESTRIANS NO PARKING ON THE ROAD Thank You City of Homer Parks and Recreation Advisory Commission

Mr. Meyer responded that Public Works staff could address the grading of the overflow parking areas in the park in the very near future.

Signage discussed was the following:

- No Parking Violators Will be Towed
- Overflow Parking
- Crosswalk

Vice Chair Brann inquired how they could establish this policy of no parking on the road. Ms. Krause responded that she will research the requirements to establish this policy but it would probably have to apply to all parks to be uniform.

Mr. Meyer will review the budget to determine signage purchase, staff can print up flyers. Vice Chair Brann will contact user groups to fund signage he would prefer not to take money from Ms. Otteson budget.

- B. Woodard Creek Trail
  - 1. Proposed Trail location(s) and Funding
  - 2. Proposed Draft for Karen Hornaday Park Master Plan

Commissioner Lowney read her proposed paragraph into the record regarding the footbridge over Woodard Creek.

It is the recommendation of the Parks and Recreation Advisory Commission that the proposed plan bridge Woodard Creek with an ADA Accessible bridge be removed from the proposed plan at this time. Documents referring to Phase II of Karen Hornaday Park Master Plan and Woodard Creek Trail Bridge should note this change and the cost of this portion of the project should reflect the change.

The commission would like it footnoted that a footbridge across Woodard Creek can at any time be added to the Karen Hornaday Park Master Plan if a need for this structure arises and funds become available.

The commissioners offered comments on the inclusion of the paragraph into the Master Plan for the park.

The paragraph was approved by consensus of the commission at the April 17, 2014 meeting.

Vice Chair Brann commented on expending the funds raised by the Friends of Woodard Creek and how the trail should be built without being held hostage by this funding.

Additional discussion on installation of a trail next to or near Woodard Creek was entertained by the commission. Some items covered were:

- Expending any funds of the Friends of Woodard Creek should be addressed by the Friends.
- Any trail that is built should be according to trail building best practices
- Recommendations from the friends on a proposed trail would be beneficial
- Many suggestions on starting that trail
- Sustainability
- Questioned if it is practical to have a trail from the campground to Fairview Avenue

There was a discussion on setting a date to stake out a trail. Preference was noted that Commissioner MacCampbell be in attendance and that if four or more commissioners attended or walked the proposed trail then it would require the visit ti be advertised.

C. Park Day Event - Confirmation if Time and Date and Discussion on Planning the Event

The commissioners discussed the event and the following was determined.

- The event will be held on August 9, 2014, Saturday at 2:00 pm
- Will start at Coal Point Park, Fish Dock Road, Homer Spit, Homer
- Commissioner Brann will seek agreement and permission from the harbormaster to approach vendors and retailers regarding participation.
- recommend they address offering food or discounts in recognition of the event
- Urge visitors to walk the new boardwalk and view the sights appreciate the artwork and new restroom facilities while soaking up the little known History of the Spit
- Vendors across the street if unable to have a table can provide a "sign" to their businesses
- Story leading up to the event use of the coal car that was at Wildberry
- Staff will provide information to the clerk on historical information about the park

Commissioner Lillibridge will obtain a piece of art to use in the advertising of the event.

Commissioner Lowney will contact Michael Armstrong regarding an article in the Homer News.

There was a brief discussion on the status of interpretative signage and public art along the trail.

D. Safe Routes to School - Status Update and Discussion

Commissioner Lowney stated a motion was needed to postpone until the August meeting.

There was a brief discussion on information that will be presented to the discussion.

## **NEW BUSINESS**

A. Karen Hornaday Park - Discussion on Park Boundaries and relocation of Park Entrance and Feasibility and Continuation of Fill Placement in the Park

The commission discussed the issue of continuation of dumping in the park and provided pictures they had taken during the recent clean-up day. Staff was unaware of any projects that had excess materials to be disposed of and will look into the issue. The sentiment was expressed that the culprit be found and made to remove the materials.

Commissioner Brann will be addressing the issue of steel caps that were removed from the docks in the harbor and placed in the park. Some of these were re-purposed but there are several more that need to be removed. The commission would like permission to sell the remaining caps and use the monies for additional improvements at the park.

Staff informed the commission that it was highly unlikely the corners had been marked with present day markers, Beth Cumming offered information on the east side boundary markers and where an old shed is encroaching on the park property as she had Kenton Bloom out several years ago. This may be something that they address in the future. Staff further noted it may be something that they need to hire a surveyor to complete.

A brief discussion on the driveway easement provided to the property owners north and adjacent to the park property. This easement is granted in perpetuity.

Next the commission discussed the feasibility of changing or adding an entrance from Danview into the park. Staff advised that they would need to request funding from Council to hire someone to look at that project since it would be more entailed than Carey drawing on a napkin. It was requested to put this on the June agenda to provide additional information on what would be necessary to design, construct and implement a project.

B. Discussion on Trails and Beach Access Trails using Right of Ways, Easements and Section Lines

The commission reviewed the maps provided by Ms. Cumming.

The commission entertained discussion on the benefits to addressing all the accesses noted on the maps and that some would be more problematic than others. It was noted that it would be very beneficial to pursue the Shelford Street as a priority trail access. Staff confirmed that the future plans for Danview, Shelford, and others to be through streets.

Vice Chair Brann requested the commissioners to review and prioritize the accesses so they can be discussed at the August meeting.

There was a brief discussion on some easements do not allow a practical way to access the beach and or allow for parking.

C. Discussion on Public Acknowledgement of Park Clean Up and City Wide HOWL at a Council Meeting

Commissioner Brann recognized the efforts of the two groups at the recent Council meeting during the commission report. He then asked if the commission would like further recognition of the efforts of these groups. Commissioner Lowney brought up the previous acknowledgment of sports teams by Council so she felt that these groups deserve the same.

Staff will check on the process to issue a proclamation or recognition from Council.

Commissioner Lowney will obtain the necessary information.

D. Welcome New Student Member!

The commissioners expressed pleasure at the prospect of having a young person attending the meetings even for a short time.

Mr. Meyer informed the commission on the project status for Spit Trail, Bishop's Beach Park, trail along Charles Way and Greatland trail; the bids will be in hand for the relocation of the existing pavilion in the area between the upper fields, bringing the access road around the shelter also.

Mr. Illg reported attending the recent meeting of a Folk School and suggested inviting Chad Jones to the September or October meeting.

## COMMENTS OF THE COMMISSION

Commissioner Archibald commented the proposed location of the existing location interfering with other planned events.

Commissioner Brann commented on the improvements at Mariner Park. He thanked staff for all they provide the commission.

Commissioner Lowney commented on the sweeping that was done, kudos on the parks and trails improvements, thanked Carey and Angie for all their hard work.

Commissioner Lillibridge great meeting, proud of all the work that was completed this month already, expressed concern over the safety issues with cyclists and pedestrians.

Commissioner Roedl expressed it was a great meeting.

**Needs Assessment Update:** Council awarded the contract to Agnew::Beck, at the June 9<sup>th</sup> meeting. Administration will work on the final contract details shortly. The project will likely begin the first week in July. I may have an update at the meeting. At the August meeting, I will have a schedule for the project.

<u>Park Day:</u> at the park walkthrough, it was mentioned that moving park day up one weekend might work better for people's schedule. The Commission can discuss this and make a motion. Also, please set a budget for this event, including advertising. We do not have another meeting scheduled between now and Park Day.

<u>Spit Trail Improvements</u>: At the walkthrough, we talked about some finishing touches for the Spit Trail. Things like enough picnic tables, distance markers, etc. If you think of an amenity that would be nice or is needed, let staff know! I will keep a list. The Commission can make a budget request, using HART Trail funds, in August.

## Karen Hornaday Park

- A. Park Road: The commission wanted more information on moving the main park entrance to Danview. I asked Public Works what the cost was to replace the creek crossing at Soundview Ave. Just that repair of the existing road was \$241,000. The creek crossing at Danview is more difficult, and likely more expensive, in addition to the cost of constructing the road into the park.
- <u>B. National Park Service Rivers, Trails and Conservation Assistance Program.</u>
  Commissioner Brann requested this be discussed.
- <u>C. Amending the Park Plan/Woodard Creek Bridge</u>. At the last meeting, the Commission discussed revised language for the park plan. Please provide it to staff so I can amend the plan and forward your recommendation to the City Council.
  - **<u>D. Parking Issues</u>**. Requested by Commissioner Lowney.

**Coal Point Park:** At the walkthrough, three improvements were mentioned.

- 1. Need a new park sign
- 2. Stairs down to the beach by the harbor mouth
- 3. Pave parking lot with day use parking for the park, and fish dock worker parking areas parked. Use HART funds.

I have asked Angie if she has funding for a new sign. If not, all three items would be good budget requests to make at this meeting.

**New CIP Projects:** The month of June is when new Capital Improvement Projects can be nominated. Council makes the final decision on what projects will be included. This is the Commission's opportunity to request new (or updated) projects. The CIP is used to lobby for state and federal funding. A project generally must be on this list when applying for grant funds. If a project is not included, that means it is not a community priory **OR**, the project is not shovel-ready enough to ask for construction funding.

There are three projects for the Commission to consider, that staff knows of. If you have another project, please bring a description to the meeting. At this June meeting, we don't have to have the whole budget request figured out; staff just needs a motion of whether these items should be on the CIP, and the general goal of the project. Katie Koester can then work up a more detailed project and budget request. There are currently five near term park projects on the CIP, and they can be amended, deleted, etc. See attachments. At the August P&R meeting, the Commission has the opportunity to tell Council what the most important park project is.

Projects that need brief discussion:

- 1. K Hornaday Park: Phase 2. Funding request could include all or parts of: design funds for moving the road, parking lot improvements, traffic calming funds, money for a garage/storage building for little league, batting cage repair?
- 2. Rogers Loop Trailhead: (Currently on the CIP as a Kachemak Nordic Ski Club project) Funds to buy land for a parking lot, trail head and restrooms, and elevate power lines. Having this project on the CIP means we can leverage HART funds and grants funds to make this project happen. Staff suggests calling this Phase 1, requesting funds to buy the land with a City match from HART Trails funds.
- 3. HERC: Brought forward by Commissioner Lowney and a citizen. What is the Commission asking for?

The donation proposal was presented to the commission at the September 2013 meeting as a concept and that the Old Town group would be advertising request for proposals no later than the first of the year. Rachelle Dowdy's artwork is primarily made up of sculptural images of birds and animal-human hybrids. Combining organic materials, such as wood and fibers, with concrete, industrial resins and recycled materials like nails, disc blades, scrap steel and wood. The combinations of images and materials address contemporary issues of life in the north, while putting a spin on popular Alaskan wildlife and motifs.

Rachelle was born in Fairbanks, Alaska in 1971.

She received a B.F.A in sculpture in 1996, from University of Alaska Fairbanks. She has also taught sculpture at the University of Alaska Fairbanks.

Dowdy was a recipient of a Rasmuson Foundation Fellowship and a Marie Walsh Sharpe Art Foundation Summer Seminar scholar.

She participated as an artist-in-residence at Denali National Park, University of Alaska Fairbanks, and Fairbanks North Star Borough School District.

Dowdy has exhibited throughout the state of Alaska, including ANC: International Gallery of Contemporary Art, Anchorage Museum of History and Art, Alaska Pacific University and OutNorth. FAI: The Annex, Well Street Art Company, Fairbanks Arts Association, and the University of Alaska's Museum of the North. She has also exhibited in Homer at Bunnell Street Gallery.

Rachelle Dowdy's work is held in many public collections, including the Anchorage Museum at Rasmuson Center, University of Alaska's Museum of the North, the state's Percent for Art Program, and the Municipality of Anchorage 1% for Art Program. Dowdy completed a private commission for the WILD Foundation: four life-sized ferro-concrete sculptures titled *Wilderness*, *Wildlands and People: A Partnership for the Public, which was installed in downtown Anchorage and gifted to the City of Anchorage and the people of Alaska. In November 2009 at Ted Stevens International Airport her latest large-scale 1% for Art piece, <i>From Here to There and There to Here* was dedicated.

As one of the co-founders of SoNot, a coalition of six visual artists, she organized numerous exhibitions throughout Alaska, including a series of *One Night Art Stands* set in alternative venues. SoNot's final project was to curate *Double XX*, the first comprehensive look at contemporary women artists in

Alaska, exhibited in 2003 at the Fairbanks Arts Association Bear Gallery. Rachelle currently lives and works in Ester, Alaska.

## Description:

Pacific Loons are indigenous to the area, but nonetheless it is a special experience to encounter these spectacular birds. Bishops Beach offers the unique opportunity for sharing these amazing spaces and moments.

The ferro-concrete loon figure will stand 8-9' in height. The concrete pedestal/pad will add 16-24" to the overall height. Affixed to an aluminum mounting plate and additionally supported through the sculpture's fist soars a commercial grade windsock on a 12' pole. This anthropomorphic sculpture is not only a reminder of our shared space, but the windsock gives us an instant visual cue too the immediate conditions we are about to immerse ourselves into.



Brianna Allen, Old Town Development Coordinator has requested the Parks and Recreation Advisory Commission support and recommend to City Council for placement at Bishop's Beach Park in the desired locations indicated on the application.

Partnering with the Center for Alaskan Coastal Studies, Lynn Naden is proposing to lead a community relief art sculpture that uses marine debris to form a silver salmon (50 x 159 "). There is also a net that will also be used to encourage visitors to the beach to place trash that they may have removed during their visit or walk along the beach. This will be maintained by the Center for Alaska Coastal Studies on a regular basis.

A sketch and the donation proposal follow this memorandum.

The request for placement is within Bishop's Beach Park attached to a windscreen on the picnic pavilion.

Brianna Allen has approached Angie Otteson, Public Works, Parks Maintenance who expressed support and approval of the placement of the proposed artwork.

Accordingly with the Donation Proposal Process the organization must get the support and recommendation from the Public Arts Committee and any other department or commission that may have an interest in the donation. The Public Arts Committee approved and recommended acceptance and placement as indicated at their special meeting on May 13, 2014.

It will go before Council via Resolution at the last meeting in June for formal acceptance.

#### **BACKGROUND**

Asia Freeman had requested the Public Arts Committee forward a recommendation to City Council to provide \$10,000 as a match to purchase the sculpture referenced as Buoys and Barrels. This sculpture is currently on display at the Bunnell Art Gallery and will be dismantled late June. It is the artist's intention to sell this artwork and have it on permanent display in Homer. The Committee was further asked to express support for the permanent placement in the End of the Road Park.

It was indicated that the Bunnell Gallery should be able to obtain the remaining \$10,000 to purchase the sculpture if the City of Homer provides the matching funds from a nearby landowner.

This issue is expected to be on the City Council's July 28, 2014 agenda.

#### **COMMITTEE ACTION TAKEN**

While admitting that the sculpture as presented represented a large part of Homer's culture, the Public Arts Committee did not support a recommendation to purchase the sculpture and further did not support placement in the End of the Road Park.






## **Priorities**

- Regrade ADA Parking Space. Pave with asphalt if feasible, provide striping to show access aisle.
- Provide accessible pathway connection between ADA Parking space and playground structures, with compacted gravel or asphalt. Longitudinal slopes shall be less than 4.5% and cross slopes shall be less than 1.75%. End pathway with small roundabout at end with digging area in center. Provide accent plantings between pathway and fence
- Replace white picket fence and gates along West, South, and East perimeter of park with new fence design.
- Remove existing play structure, swings, sand, and timber edging. Replace with new structure, 2-bay swings, tile surfacing, and new timber edge.
- Create park entrance area. Provide accessible surfacing, location for future artwork/play sculpture, provide trash can, park signage, benches, BBQ grills, and drinking fountain.
- Connect play elements with stepper pathway on top of hill. Create playhouse on top of hill.
- Add more play connections on other side of drainage. Create look-out or birdwatching station at highpoint in NW corner of site. Add bench at NE corner of site. Create pathway between elements with steppers and balance beams.

## **Existing Fence**

The existing fence is a white, vinyl picket style fence. It is relatively low, approximately 36" height (can we have this verified?). It surrounds the park on the west, south, and east sides. A tall, chainlink fence runs along the Park's north boundary.

The fence is one of Bayview Park's greatest features, as it completely encloses the park (with gates provided for entry) allowing younger children to play safely in a large area that is easily supervised by parents. The fence is also low enough that it does not obstruct views to Kachemak Bay.

The concern with the existing fence is that it requires constant maintenance. Pickets are constantly falling off creating holes in the fence large enough for small children to fit through.

## **Recommended Fence Design**

Community member would like to replace the existing white picket fence with a sturdier fence requiring less maintenance, allowing attachment of artwork, while preserving the open view from the Park to the water.



The low, chainlink fence at Fireweed School (above) shows the how artwork can easily be attached to this type of fence and create a unique character for the Park.





Wood-framed chainlink fencing is a good option for the replacement fence because it offers a sturdy frame with clean edges. If maintained at a low height to match the height of the existing fence, it will not obstruct views to Kachemak Bay and can allow attachment of artwork.





## **Existing Play Structures**



The existing play structure at Bayview Park is relatively small piece of equipment with wood posts and plastic components. It is surrounded by sand for safety surfacing with timber edging. The posts are coming out of alignment due to frost-heaving and are occasionally reset.



The swings are a single bay 3-post standard swing set (8' height top bar? Can we have this verified?). In the past year, the community was able to purchase an adaptive swing and harness for this set. It is currently shown with two toddler bucket seats.

## **Case Study - Replacement of Play Equipment**



Before

In 2011, Corvus Design worked with Kids' Corps Inc. to develop master plans for five of their playground sites in Anchorage. Kids' Corps Inc. is a non-profit, Anchorage-based Head Start agency. They pursued funding for improvements for one of the sites (pictured above). This location served a maximum number of 42 children under the age of five.

This site had a composite plastic structure with missing pieces surrounded by pea gravel fall surfacing. They needed to replace the structure, but wanted to maintain an area for digging while increasing the surface area for riding tricycles.




After

They were able to obtain funding for a creation of a timber-edged digging area, removal of some of the pea gravel, placement of rubber tile fall surfacing on asphalt base, and volunteer-installation of a new structure.










## Ben Walters Park Improvements, Phase 2

**Project Description & Benefit**: Ben Walters Park comprises 2.5 acres on the shore of Beluga Lake, near the intersection of Lake Street and the Sterling Highway. With its central location, proximity to McDonalds restaurant, and access to the lake for winter and summer recreation, it is one of Homer's most frequently visited parks. Phase 2 will enlarge the parking area and renovate the picnic shelter that has become worn with heavy use over the years.


Plans & Progress: Phase 1 of the park improvement project, to replace the dock, was completed in 2009. Since then the Kachemak Bay Rotary Club has adopted the park under the City of Homer's Adopt-a-Park Program. They have made improvements such as painting the restrooms, installing a bench, resetting the posts and tending flower beds in the summer months.

Total Project Cost: \$250,000

Schedule: 2015 Priority Level: 2



Improvements are needed at Ben Walters Park, including enlarging the parking lot and renovating the shelter.





## **Jack Gist Park Improvements, Phase 2**

**Project Description & Benefit**: Jack Gist Park has been in development since 1998 on 12.4 acres of land donated to the City of Homer by a private landowner. As originally envisioned by the Jack Gist Recreational Park Association, this parcel was to be developed primarily for softball fields.

**Cost**:The proposed project will complete Phase 1 of Jack Gist Park by expanding the parking lot, constructing a concession stand/equipment storage building adjacent to the softball fields, and developing an irrigation system utilizing a stream on the property in conjunction with a cistern. Phase 3 will provide potable water (water main extension), construct a plumbed restroom, and develop soccer fields.

Plans & Progress: Phase 1 of this project was completed in 2011. In 2005-2006, a road was constructed to Jack Gist Park from East End Road, a 70-space gravel parking area was constructed, and three softball fields were constructed including fencing, dugouts, and backstops. In 2008, bleachers were installed at all three softball fields. In 2009, three infields were resurfaced. In 2010, with volunteer help, topsoil was spread and seeded on two fields and the parking area was improved and expanded. In 2011, drainage work was completed on the outside perimeter (right and left field lines) of the third ball field, material was imported to improve the infield, and the outfield was improved with topsoil and seeding.

Total Project Cost: \$155,000 Parking Lot Expansion: \$45,000

Concession Stand and Equipment Storage: \$75,000

Irrigation System: \$35,000

Schedule: 2013 Priority Level: 2





## Karen Hornaday Park Improvements, Phase 2

**Project Description & Benefit**: Homer's popular Karen Hornaday Park encompasses baseball fields, a day use/picnic area, a playground, a campground, and a creek on almost 40 acres. It is also used to host community events such as the Highland Games and KBBI's Concert on the Lawn. The Karen Hornaday Park Master Plan, updated and approved in 2009, sets forth goals and objectives to be accomplished over a 10-year period. The Master Plan includes improvements to the ballfields, playground/day use area, rehabilitation of Woodard creek including trail access, moving the road and improved parking, new restrooms, and campground improvements. Phase 1 projects have been completed or are scheduled to be completed by the end of 2012. Phase 2 consists of parking lot improvements, moving the road, a trail along Woodard Creek and a restroom. The road to access the park runs between the park and the parking lot, causing kids to have to cross in front of traffic to get to the park's attractions. The master plan proposes moving the road to the east and placing the improved gravel parking lots in between the road and the park. Woodard creek is one of the jewels of Karen Hornaday Park but gets little attention because there is no convenient way to access it. A trail along the creek would allow people to enjoy the city's only creek. One of the most common complaints of the park is the old restroom with crumbling cement and a leaking roof. A new restroom is in great demand from the parents, children and picnickers that frequent the park.


Plans & Progress: The Alaska Legislature appropriated \$250,000 for park improvements in FY 2011. This money together with City funds and fund raising by an independent group organized to make playground improvements (HoPP), has funded Phase 1 (drainage improvements, ballfield improvements, new playground, new day use area and northern parking lot improvements). The City has designated \$50,000 to help fund design and engineering for Phase 2. The City received a Land and Water Conservation Fund (LWCF) grant for campground and drainage improvements and the development of a new day use area between the two ball fields.

Total Project Cost: \$1,978,750

Schedule: 2014 - 2016 Priority Level: 2



Karen Hornaday Park was a construction site for one week during the Summer of 2012 when the community came together to build a state of the art play ground.





### **Mariner Park Restroom**

**Project Description & Benefit**: As one of Homer's most popular recreation areas, Mariner Park attracts campers, beach walkers, kiteflyers, Spit Trail users, birders, people with dogs, and others who come to enjoy the views and open-air recreation opportunities. This project will accomplish the most pressing need at Mariner Park: the construction of a plumbed restroom to better meet the needs of campers and beach walkers during the busy summer months.

**Plans & Progress**: Design costs for this project would be minimal as the City has standard public restroom plans engineered that can be easily modified for this location. Total Project Cost: \$330,000

Schedule: 2015

**Priority Level**: 2

## Baycrest Overlook Gateway Project

**Project Description & Benefit**: The Homer Public Arts Committee has designated the Baycrest Hill Overlook as one of the major elements of the Gateway Project, which entails enhancing visitor and resident experiences at the entrances to Homer. The other Gateways are the Homer Airport and the Homer Port.

Everyone who has driven to Homer remembers the first time they came around the corner on the Sterling Highway and saw the breathtaking panorama of Kachemak Bay. For many that was the same moment they made the decision to become part of this diverse, eclectic, and energetic community. In the 1990s visionaries at Alaska Department of Transportation and Public Facilities constructed the current pullout during the Sterling Highway reconstruction effort. However, the current site does not adequately meet the goals of the Gateway Program.

Improving the landscaping and comfort of Baycrest Overlook will inspire locals and visitors and enhance this phenomenal setting. Interpretive signage will tell the story of Homer and the surrounding communities and highlight the phenomenal natural resources of Kachemak Bay. Improvements to the overlook will spur economic development, welcoming everyone and encouraging commerce and trade in a community dedicated to unique and natural quality of life experiences.

**Plans & Progress**: The first Gateway Project was undertaken in 2009. A collaborative effort with the City of Homer Public Arts Committee, City of Homer Airport Manager, City of Homer Public Works Director, Alaska State Parks, National Park Service, Kachemak Research Reserve and U.S. Fish and Wildlife created a beautiful diorama highlighting the wealth of public and private resources available to everyone who comes to Kachemak Bay.

This group plus representatives from Alaska Department of Fish and Game, Alaska Department of Transportation, Pratt Museum, Homer Chamber of Commerce, Kachemak Bay Conservation Society and Homer Garden Club have come together to work on the Baycrest Overlook Gateway Project.

The State and the City of Homer spent \$6,000 in 2013 to produce the Baycrest Overlook Interpretive Plan. The Plan included design, development, and locations for welcome and interpretive signage and was officially adopted by Council in 2013. Public Arts Committee meetings on the project are ongoing and a public comment meeting was held on September 18, 2012.

#### The project will consist of three phases:

- 1. Interpretive signage, benches and picnic areas
- 2. Enhanced landscaping
- New restrooms and paving upgrades.

Total Project Cost: \$256,000 2012 (Design): \$6,000

> 2014 (Construction): \$250,000 Signage/Benches: \$100,000 Landscaping: \$75,000;

Restrooms and Paving: \$75,000







## Capital Improvement Long-Range Projects

The following projects have been identified as long-range capital needs but have not been included in the Capital Improvement Plan because it is not anticipated that they will be undertaken within the six-year period covered by the CIP. As existing CIP projects are funded or as other circumstances change, projects in the long-range list may be moved to the six-year CIP.

#### Local Roads

Fairview Avenue – Main Street to East End Road: This project provides for the design and construction of Fairview Avenue from Main Street to East End Road. The road is approximately 3,000 linear feet and the project will include paving, water and sewer mains, stub-outs, storm drains, and a sidewalk or trail. The project extends from the intersection of Main Street to the Homer High School, and finally to East End Road, and will provide an alternative to Pioneer Avenue for collector street access east/west across town. This roadway would benefit the entire community by reducing congestion on Pioneer Avenue, the major throughtown road, and would provide a second means of access to the high school. It would also allow for development of areas not currently serviced by municipal water and sewer.

This improvement is recommended by the 2005 Homer Area Transportation Plan. Necessary right of way has already been dedicated by the Kenai Peninsula Borough across the High School property.

Cost: \$1.75 million Priority Level 3

Fairview Avenue – Main Street to West Hill Road: This project provides for the design and construction of Fairview Avenue from Main Street to West Hill Road. The road is approximately 4,200 linear feet and the project will include paving, water and sewer mains, stub-outs, storm drains, and a sidewalk or trail. Along with the Fairview to East End Road project, this project will benefit the entire community by providing an alternative to Pioneer Avenue for collector street access east/west across town, thereby reducing congestion on Pioneer Avenue and developing alternative access for emergency vehicle response. The need for the road extension has increased markedly with the development of three major residential subdivisions in the area.

This improvement is recommended in the 2005 Homer Area Transportation Plan.

Cost: \$3 million Priority Level 3


#### Parks And Recreation

Beach Access from Crittenden and Main: This project will provide residents and visitors with coastal viewing stations and access to the beach at the southern ends of Crittenden Street and Main Street, utilizing City-owned land. The project will enhance connectivity in Homer's developing trails and park system, providing additional points of access so that beachgoers can walk onto the beach at one point and off at another, on a loop through Old Town, Town Center, etc. For those not physically able to walk all the way to the beach, platforms near the roads will provide nice views and benches on which to relax. Interpretive signage could provide information on Homer history, beach formation, and other topics.

Improvements at Crittenden Street will consist of stairs with landings (designed to protect against erosion) constructed from the top of the bluff to approximately halfway down the slope. From there, a narrow, meandering pathway will continue to the beach.

The Main Street beach access point is envisioned to have a small parking area, a viewing platform with a bench, and stairs with landings.

Cost: \$250,000 Priority Level 3





## Capital Improvement Long-Range Projects

East Trunk/Beluga Lake Trail System: This project will create two connecting trails:

- The Beluga Lake Trail will partially encircle Beluga Lake with a raised platform trail that includes a wildlife observation site.
   The trail will connect neighborhoods and business districts on the north and south sides of the lake.
- The East Trunk Trail will provide a wide gravel pathway from Ben Walters Park east along the City sewer easement, along the
  north side of Beluga Lake (connecting with the Beluga Lake Trail), and eventually reaching East End Road near Kachemak
  City.

The completed trail system will connect Paul Banks Elementary School, the Meadowood Subdivision, and other subdivisions and residential areas to Ben Walters Park. It will additionally provide hiking, biking, and wildlife viewing opportunities around Beluga Lake. In addition, it will provide an important non-motorized transportation route.

The Beluga Lake Trail and a trail connection to Paul Banks Elementary School and East End Road are included in the 2004 City of Homer Non-Motorized Transportation and Trail Plan.

Cost: Beluga Lake Trail—\$1.5 M

East Trunk Trail-\$2 M

Priority Level 3

Horizon Loop Trail, Phase 1: The Homer Horizon Loop Trail is proposed as a four to five mile route that would run clockwise from Karen Hornaday Park up around the top of Woodard Creek Canyon, traverse the bluff eastward, and then drop down to Homer High School. The parking lots of Karen Hornaday Park and Homer High School would provide trailhead parking. Those wishing to complete the loop will easily be able to walk from the high school to Karen Hornaday Park or vice versa via Fairview Avenue. A later stage of trail development will connect the Horizon Loop Trail with the Homestead Trail at Bridge Creek Reservoir.

Cost: Staff Time

Priority Level 3

Jack Gist Park Improvements, Phases 3: Jack Gist Park has been in development since 1998 on 12.4 acres of land donated to the City of Homer by a private landowner. As originally envisioned by the Jack Gist Recreational Park Association, this parcel was to be developed primarily for softball fields. The long-term goal is to acquire adjacent properties that will provide space for soccer fields. Phase 3 development will construct a plumbed restroom at the park. Phase 3 will be to develop soccer fields.

Cost: \$400,000

Priority Level 3

**Karen Hornaday Park Improvements, Phase 3**: Phase 3 park improvements will include building a concession stand, shed, new restroom, landscaping, signage, and revegetating Woodard Creek.

Cost: \$860,000

Priority Level 2

Mariner Park Improvements: This project will provide significant improvements to Mariner Park as called for in the park's master plan: Construct a bike trail from the "Lighthouse Village" to Mariner Park (\$325,000); expand the park and move the vehicle entrance to the north (\$175,000); Construct a pavilion, additional campsites, and interpretive kiosk (\$150,000); and improve the appearance of the park with landscaping (\$75,000).

Total: \$725,000

## Capital Improvement Long-Range Projects

**Public Restrooms – Homer Spit**: With increased activity on the Homer Spit, including the popular Homer Spit Trail, the need for restroom facilities has also increased. Restrooms are needed in the following locations, in priority order. (Note: It is anticipated that a new restroom in the vicinity of the Fish Dock will be constructed in 2013. Restrooms for Mariner Park and End of the Road Park are addressed elsewhere).

- The restroom at Ramp 2 is in poor condition and needs to be replaced. If a new Port & Harbor building is constructed, it could
  include a restroom (possibly with showers) to replace the Ramp 2 restroom.
- A restroom is needed at the trailhead parking area on Kachemak Drive. The parking area is at the intersection of the Ocean Drive bike route and the Homer Spit trail; thus the restroom will benefit users of both trails.

#### **PUBLIC FACILITIES**

**Homer Conference Center**: Homer is a popular visitor destination and the visitor industry is a critical component of the local economy. However, millions more dollars might be spent in Homer if a meeting facility large enough to attract conferences with several hundred participants was available. Currently, Homer has no facility capable of providing meeting space for groups of more than 180 people.

Homer's reputation as an arts community will help attract meetings and audiences if a facility exists to accommodate and showcase these events. The conference center, featuring banquet/ballroom space and flexible meeting space, will fill this need. If the facility is located in Homer's developing Town Center, other area businesses would also benefit from the increased number of visitors attending meetings at the conference center.

A conference center will increase Homer's ability to compete with other communities in that important niche of the visitor industry, and will also provide a venue for meetings and cultural events hosted by local organizations, such as the Kachemak Bay Writers Conference and Shorebird Festival events.

In partnership with the Homer Chamber of Commerce, the City of Homer commissioned a conference center feasibility study completed in summer 2005. The study predicts moderate demand from outside groups for a conference center in Homer. The Conference Center Feasibility Study Steering Committee made a formal recommendation that the City support efforts to encourage the construction of a conference center in Homer's Town Center. In August 2005, the Homer City Council passed Resolution 05-86(A) which recommends further consideration and authorizes the City Manager to pursue ideas and discussions that will increase the likelihood of a conference center being built in Homer.

Cost: \$5 million

Priority Level 3

**Public Works Complex**: The City of Homer Public Works complex on the Sterling Highway was constructed in phases from 1974-1986 (except for the recently completed large equipment storage shed). In 1980, Homer's population was 2,209. Since that time, the population has grown more than 150%, with a corresponding increase in roads, water/sewer lines, and other construction activity that requires employee and equipment time. The existing facility is no longer adequate to meet these needs and the problem will become more acute with continued growth.

A new Public Works complex will include the following:

- · Increased office space to provide adequate room for employee work areas, files, supplies, and equipment storage
- · Adequate space for Parks Division and Engineering staff and equipment
- A waiting area for the public, contractors, etc.
- · A conference room that doesn't double as the employee break room
- A break room with adequate seating, storage, and locker space
- A laundry room

WHEREAS, The Parks and Recreation Advisory Commission has advised the City Council that it is concerned with the safety of children and pedestrians at Karen Hornaday Park due in large part to excessive driving speeds and parked vehicles along the roadway; and

WHEREAS, The Commission has recommended implementing a speed limit and prohibiting parking along the roadway; and

WHEREAS, HCC 19.20.020 (f) (Parks, Campgrounds, and Public Places) provides that "motor vehicles shall be operated in accordance with posted speed limits, in a prudent and safe manner, and at a speed not exceeding ten miles per hour in parking areas"; and

WHEREAS, HCC 19.20.060 states that "The City Manager is authorized to promulgate regulations to regulate the use of park and recreational facilities"; and

WHEREAS, The City Manager has informed the Council that he intends to draft a regulation that prohibits parking along the roadway, establishes a speed limit of fifteen miles per hour on the Park Road, and install new signage as appropriate at Karen Hornaday Park; and

WHEREAS, Public health and safety in city parks is a top priority for the City Council.

NOW, THEREFORE, BE IT RESOLVED that the Homer City Council hereby approves new regulations promulgated by the City Manager which prohibits parking along the roadway and establishes a fifteen miles per hour speed limit on the Park Road at Karen Hornaday Park.

## PARKS AND RECREATION ADVISORY COMMISSION BYLAWS

The Homer Parks and Recreation Advisory Commission is established with those powers and duties as set forth in Title 1, Section 74, of the Homer Municipal Code.

The Commission is established to act in an advisory capacity to the City Manager and the City Council on the problems and development of parks and recreation facilities and public beaches within the City.

The Commission's jurisdiction is limited to the area within the City Boundaries except for those extra territorial interests, such as trails and city properties, subject to city jurisdiction.

The Homer Parks and Recreation Advisory Commission consist of seven members; up to three members may be residents from outside the city limits, preference shall be given to City resident applicants.

Members will be appointed by the Mayor for three-year terms (except to complete terms) subject to confirmation by the City Council.

One Homer area High School student selected by his or her student body shall serve as a consulting member of the Commission in addition to the seven appointed members, and may attend and participate in all meetings as a consultant, but shall have no vote. (Ord. 99-04, 1999)

There will be regular monthly meetings January through November of the Commission and permanent records or minutes shall be kept of the proceedings. The minutes will record the vote of each member upon every question. Every decision shall be filed in the office of the City Clerk and shall be public record open to inspection.

#### **HISTORY**

The By-laws were passed by the Parks and Recreation Commission on October 20, 1983 by the Homer City Council on February 13, 1984, and shall be in effect and govern the procedures of the Commission. The duties and responsibilities of the Commission are:

- A. Act in advisory capacity to the City Manager and the City Council on the problems and development of park and recreation facilities and public beaches in the city. Consideration may include existing facilities, possible future developments and recommendations on land use.
- B. Consider any specific proposal, problem or project as directed by the City Council.

#### **BY-LAWS**

- A. To abide by existing Alaska State Law, Borough Code of Ordinance, where applicable, and Homer Municipal Code;
- B. To abide by Robert's Rules of Order, current edition, in so far as this treatise is consistent with Homer Municipal Code.

#### C. REGULAR MEETINGS:

- 1. February through June and August through November on the third Thursday of the month, at 5:30 p.m. No meetings will be scheduled during the months of January, July and December unless a Special meeting is required in accordance to the bylaws.
- 2. Items will be added to the agenda upon request of staff, the Commission or a Commissioner. Agenda deadline is the Wednesday of the week preceding the meeting date at 5:00 p.m.
- 3. Removing items from the published agenda will be by consensus of the Commission. No items may be added.
- 4. Commissioners will give staff or Chair a minimum of a two week notice or as soon as possible regarding their potential absence from a meeting.

#### D. COMMITTEES

- 1. The commission shall submit a request for approval to City Council to form special committees. Committee membership shall include at least two Commissioners. The commission will submit in memorandum form to council the reason for establishing a committee, the task(s) assigned to the committee and the expected term for the committee plus a list of persons to be appointed to the committee such as Council members, department personnel, or number of public in specific sectors or with special experience preferred.
- 2. One committee member shall be appointed as Chair and work with the City Clerk's Office to create the agenda and schedule meetings so they may be advertised in accordance with Alaska State Law and Homer City Code.
- 3. One committee member shall be appointed and responsible for furnishing summary notes of all Committee meetings to the City Clerk.
- 4. Committees shall meet in accordance with Commission bylaws and Robert's Rules.
- 5. Committees will make a progress report at all commission meetings.
- 6. No committee shall have other than advisory powers.
- 7. Per Robert's Rules and the resolution creating the committee as established by City Council upon giving final report the committee is disbanded.
- 8. All meetings are to be conducted in City Hall where they may be recorded.

## E. COMMISSION MEETING PUBLIC COMMENT/TESTIMONY AND AUDIENCE COMMENT TIME LIMITS

- 1. The meeting Chair shall note for the audience's benefit that there is a three minute time limit each time there is a place in the agenda for public comment/testimony or audience comments.
- 2. Any individual wishing to address the Commission shall adhere to a three minute time limit. It is the responsibility of the Chair to announce under Public Comments, Public testimony on public hearing items and Audience Comments that there is a 3 minute time limit.
- 3. Time limits may be adjusted by the 2 minutes up or down with the concurrence of the body in special circumstances only such as agenda content and public attendance.

#### F. SPECIAL MEETINGS:

1. Called by Chair or majority of the Commission only when required to complete time sensitive business of the commission, at the request of City Administration or City Council.

#### G. DUTIES AND POWERS OF THE OFFICERS:

- 1. A Chair and Vice-Chair shall be selected annually (November meeting) by the appointive members.
- 2. The Chair shall preside at all meetings of the Commission, call special meetings in accordance with the by-laws, sign documents of the Commission, see that all actions and notices are properly taken, and summarize the findings of the Commission for the official record.
- 3. The Vice-Chair shall perform all duties and be subject to all responsibilities of the Chair in his/her absence, disability or disqualification of office.
- 4. The Vice-Chair will succeed the Chair if he/she vacates the office before the term is completed, to complete the unexpired term. A new Vice-Chair shall be elected at the next regular meeting.

#### H. MOTIONS TO RECONSIDER:

- 1. Notice of reconsideration shall be given to the Chair or Vice-Chair, if the Chair is unavailable, within forty-eight hours from the time the original action was taken.
- 2. A member of Commission who voted on the prevailing side on any issue may move to reconsider the Commission's action at the same meeting or at the next regular meeting of the body provided the above 48-hour notice has been given.
- 3. Consideration is only for the original motion to which it applies.

#### I. CONFLICT OF INTEREST:

- 1. A member or the Commission shall disqualify himself/herself from participating in any official action in which he/she has a substantial financial interest.
- 2. Should the Commission member not move to disqualify himself/herself after it has been established that he/she has a substantial financial interest, the Commission may move to disqualify that member by a majority vote of the body.

#### J. QUORUM; VOTING:

- 1. Four Commission members shall constitute a quorum.
- 2. Four affirmative votes are required for the passage of a resolution or motion.
- 3. Voting will be by verbal vote, the order to be rotated. The final vote on each resolution or motion is a recorded roll call vote.
- 4. The City Manager, Mayor and High School student shall serve as consulting members of the Commission but shall have no vote.

#### K. CONSENSUS:

1. The Commission may, from time to time, express its opinion or preference concerning a subject brought before it for consideration. Said statement, representing the will of the body and meeting of the minds of the members, may be given by the presiding officer as the consensus of the body as to that subject without taking a motion and roll call vote.

#### L. ABSTENTIONS:

- 1. All Commission members present shall vote unless the Commission, for special reasons, permits a member to abstain.
- 2. A motion to excuse a member from voting shall be made prior to the call for the question to be voted upon.
- 3. A member of the Commission requesting to be excused from voting may make a brief, oral statement of the reasons for the request and the question of granting permission to abstain shall be taken without further debate.
- 4. A member may not be permitted to abstain except upon the unanimous consensus of members present.
- 5. A member may not explain a vote, may not discuss the question while the roll call vote is being taken and may not change his/her vote thereafter.

#### M. VACANCIES:

- 1. A Commission appointment is vacated under the following conditions and upon the declaration of vacancy by the Commission.
- 2. The Commission shall declare a vacancy when the person appointed:
  - A. fails to qualify to take office within 30 days after his/her appointment;
  - B. resigns and the resignation is accepted;
  - C. is physically or mentally unable to perform the duties of his/her office;
  - D. misses three consecutive regular meetings unless excused; or
  - E. is convicted of a felony or of an offense involving a violation of his/her oath of office.

- 11. NEW BUSINESS or COMMISSION BUSINESS
- 12. INFORMATIONAL MATERIALS (NO ACTION MAY BE TAKEN ON THESE MATTERS, THEY MAY BE DISCUSSED ONLY).
- 13. COMMENTS OF THE AUDIENCE (3 MINUTE TIME LIMIT)
- 14. COMMENTS OF THE CITY STAFF (not required) (Staff report may be at this time in the agenda.)
- 15. COMMENTS OF THE COUNCILMEMBER (If one is assigned)
- 16. COMMENTS OF THE CHAIR (May be combined with COMMENTS OF THE COMMISSION/BOARD since the Chair is a member of the Commission/Board.)
- 17. COMMENTS OF THE COMMISSION
- 18. ADJOURNMENT/NEXT REGULAR MEETING IS SCHEDULED FOR \_\_\_\_\_\_ note any worksessions, special meetings, committee meetings etc. All meetings scheduled to be held in the Homer City Hall Cowles Council Chambers located at 491 E. Pioneer Avenue, Homer, Alaska. (Sometimes the meeting is scheduled for the Conference Room)

#### O. PROCEDURE FOR CONSIDERATION OF AGENDA ITEMS:

The following procedure will normally be observed pursuant to Robert's Rules:

- 1. A motion is made to discuss the item OR to approve the staff recommendation. The item may then be discussed, amended or voted on.
- 2. If there are questions of staff or an appropriate audience member, a Commissioner may request permission from the Chair to ask the question. The Chair, upon with consensus approval, may grant the request.

#### P. BYLAWS AMENDED:

The bylaws may be amended at any meeting of the Commission by a majority plus one vote of the members, provided that notice of said proposed amendment is given to each member in writing. The proposed amendment shall be introduced at one meeting and action shall be taken at the next commission meeting.

#### Q. TELECONFERENCE:

Teleconference meetings.

- 1. The preferred procedure for Commission meeting is that all members be physically present at the designated time and location within the City for the meeting. However, physical presence may be waived by the Chair or Commission and a member may participate in a meeting by Teleconference when it is not essential to the effective participation or the conduct of business at the meeting.
  - A. A Commission member participating by teleconference shall be deemed to be present at the meeting for all purposes. In the event the Chair participates telephonically, the Vice-Chair shall run the meeting.
- 2. Teleconference procedures.
- A. A Commission member who cannot be physically present for a regularly scheduled meeting shall notify the recording clerk at least five days prior to the scheduled time for the meeting of his/her intent to appear by telephonic means of communication.
- B. The recording clerk shall notify the Commission members three days prior to the scheduled time for the Commission meeting of Commission members intending to appear by teleconference.
- C. The means used to facilitate a teleconference meeting of the Commission must enable each Commission member appearing telephonically to clearly hear all other Commission members and members of the public attending the meeting as well as be clearly heard by all other Commission members and members of the public.

D. The recording clerk shall note in the attendance record all Commission members appearing telephonically.

#### **LEGISLATIVE HISTORY**

Amendment to the first paragraph was passed by the Commission on April 19, 1990 and passed by Homer City Council on May 14, 1990 via Resolution 90-34.

New section M, Alternate Voting Members was passed by Homer City Council on June 8, 1998 via Resolution 98-41.

Amendment to include Teleconference Procedures was approved by the Commission on February 15, 2001 and adopted by the City Council on February 26, 2001 via Resolution 01-09. This amendment changed the edition of Robert's Rules of Order from seventh to current and added new sections N. and O.

Amendment to the meeting time was passed by Homer City Council on February 14, 2005 via Resolution 05-17.

Amendment Revising the Agenda Layout and Content, Regular meeting procedures, Special Meeting procedures; adding Commission Meeting Public Comment/Testimony and Audience Comment Time limits, Public Beaches, Procedure for Consideration of Agenda Items; Removing Alternative Voting Members was passed by Homer City Council via Resolution 07-22(A).

Amendment Revising the Frequency of Meetings and Attendance Requirements was passed by Homer City Council via Resolution 09-79

Revising the meeting time from 6:30 p.m. to 5:30 p.m. was passed by Homer City Council on December 13, 2010 via Resolution 10-96.

Establish Monthly Meetings with the Exception of December was passed by Homer City Council on July 25, 2011 via Resolution 11-076.

Amending the monthly meetings to February through June, August through November no meetings will be scheduled during the months of January, July and December unless a Special Meeting is required in accordance with the Bylaws. Establish committees only with the approval of City Council and by Resolution was passed by Homer City Council on June 9, 2014 via Resolution 14-056

#### Cook Inlet Coal Fields Railroad

The Cook Inlet Coal Fields Company opened a mine in 1899 at Homer, AK. From 1900-1903, one or more small steam locomotives ran on an 8.5 mile, 42" narrow gauge track from the mines to the end of the Homer spit. This gauge (sometimes called "Cape Gauge") was used in several railroads in Alaska. It was also used in various municipal street railways in the lower 48, and became something of a standard in American coal mines by the 1920s (ref). (Howard Clifford says this railroad was "three-foot" gauge, but contemporary reports from the USGS refer to it as 42").

A 1901 court case against the Cook Inlet Coal Fields Co mentioned that "A number of the rails were old second-hand rails, to wit, had been used in street-car tracks" and that "The cars were old, discarded street-cars... trucks that they used to use in Seattle on the old horse-car lines." (specifically mentioned is the James Street line, a 42"-gauge cable and horse trolley line which was electrified around 1899). The rails were bought from the W.D. Hoffens firm at \$35/ton. The locomotive is described as a newly-built "Port & Son" (Probably H.K. Porter) ten-ton engine. The locomotive was "set up" and track laying began on June 23, 1900.

The Cook Inlet Coal Co was incorporated under the laws of West Virginia, but apparently based in Philadelphia, PA. President of the company was Captain Alfred Ray, VP was Edward Anderson Ryon, and Secretary Treasurer was Clarence Eugene Lent. Other stockholders included A.N and A.S. Chandler, and W.B. Addison. Initial authorized capital was \$1,650,000.

An investment article in 1901 claimed that the company had spent most of their efforts developing the railway, dock, and a sawmill, and had not yet begun to mine coal extensively, although the quantity of coal was claimed to be "unlimited". A.S. Chandler & Co of Philadelphia had taken a first mortgage of 6% gold bonds on the property. The company's officers were described as "Philadelphia business men of high standing and means".

Despite the "unlimited" quantities of coal, the quality proved lower than that available from California and Washington State. While suitable for heating, the coal had only 70% of the fuel value of competing deposits, and was not efficient for the target steamship market. (The Russians had discovered this as early as 1856 when they attempted to use Kachemak Bay coal in their steamers). By some accounts, the mines and railway ceased operation in 1902 or 1903, with the last loaded train left to sit for several years. On Sept 7, 1904, West Virginia creditors petitioned to have the company put into involuntary bankruptcy. An article from the Homer Tribune notes a 1905 bankruptcy sale, indicating that there may have been two locomotives worth \$3,000. Other property auctioned off included ten coal cars, five old street cars, and various livestock. Despite appeals by the company, the bankruptcy was upheld.

The line may have seen some use after the bankruptcy, as some of the investors attempted to retain control of the coal deposit. The Michigan-Alaska development company, also known as the McAlpine, Mackey, and Bushnell groups, purchased the railroad and the town of Homer in 1906 and 1907 (some of these same people seem to have been involved as early as 1900). They soon faced conspiracy charges in Federal court relating to the re-staking of claims in the area. Supposedly the new company had solicited hundreds of Detroit residents to file mining claims on their behalf, in order to side-step new Federal restrictions.

Barred from mining coal, the Michigan-Alaska syndicate began scrapping equipment in 1912. The rails were removed around 1913, and salvage firms shipped more equipment to Seattle between 1913 and 1915. Some of this salvage work resulted in further court cases.

At least one newspaper article paints a picture of deliberate scandal and fraud around the operation, claiming that the entire town of Homer had been built as a sort of Potempkin village:



"BUILT FAKE TOWN TO GET PICTURES AND SELL STOCK ... This company sent north, the government charges, a number of grading engines, dump cars, and street cars and built the uninhabited town of Homer, with saloons, dance halls, hotels, etc, in order that pictures might be taken for the prospectus used by sellers of stock. The machinery and other relics were brought to Seattle last week and the "town" is now entirely abandoned." From Meriden Morning Record, 5 Dec 1913

A visitor to Homer in 1910 reported "roundhouses, machine-shops, engines and cars"... implying multiple locomotives on the railroad.

Other coal mines operated in the area during the late 20th century. The Cook Inlet Coal Fields Co had planned to expand their railroad to several other mines around Homer, including Moose Station and Coal Creek. In 1894 the North Pacific Mining and Transportation Company operated a tram 1/2 mile from the shore to a mine in Eastland Canyon, about 14 miles northeast of Homer.

It will be a great way to highlight your business while making the community more aware of the trail and the historical significance of Coal Point.


