 - C. Shelter Advisory Committee Sherry is thinking April is too far out would like to set a tentative meeting in February or March with Will and Melissa depending on schedules
 - D. Homer City Code Chapter 20, Animals Code last updated 1988, very outdated Casey The definitions of terms in the Soldotna and Kenai codes are much clearer and would be helpful.
 - Melissa- Advise that the SACRC recommends to expedite revised code for approval.

Francie – Wanted to address Dot's concern about code for restrained/tethered animals in vehicles. Would it need to be cross referenced in the traffic code? Anchorage has code could maybe look at that as an example

A. Boarding Agreement Form – Received example boarding contract which needs some modification to work for the city. Liability waiver is important.

Melissa – Change some of the requirements about boarding, re: fecal samples

Sherry – Likes document, city should add disclaimer

Casey – Can forward an electronic copy. Would recommend a limit on the number of dogs that can be boarded so there is always space for dogs that may come into the shelter

Sherry – Urges someone to open boarding kennel to fill void in the Homer area

Will – Is there the technology for checking for microchipped animals?

Casey – Space on licenses to add microchip numbers?

Sherry – Forms need to be updated, just write any extra info on form

Francie – Computer used and or/available for database
