## IF YOU ARE RENEWING A CURRENT CHAUFFEUR LICENSE

1. You **MUST** renew your chauffeur license BEFORE it expires (the same as your Alaska driver's license).
2. If your chauffeur license has not expired, you may pick up a Chauffeur License Renewal Application from the Homer Police Department.
3. Complete the Chauffeur License Renewal Application, provided in the packet.
4. Return the completed and signed application to the Homer Police Department along with:
  - a. Proof of a physical exam within the last thirty days (forms provided by your doctor);
  - b. Check or money order made payable to the City of Homer in the amount of \$75 to cover application processing fee. Cash will be accepted for this fee.
  - c. Your current City of Homer Chauffeur License. A copy of your current license will be made and attached to your renewal application. Your license will be returned to you for use until the new license is issued.
5. Applications are usually processed by dispatch within twenty-four hours. However, processed applications can only be reviewed by department administration Monday through Friday, 8am-4pm (not including holidays). The same photo used on your old license may be used on the renewed license, unless your appearance has changed significantly, a new photo may be taken. After approval of your renewal by the administration, you may pickup your new license within twenty-four hours.
6. Your license will be good for approximately two years, depending upon when you apply (all Chauffeur Licenses expire on December 31<sup>st</sup>). **Be sure to check the expiration date on your new license.** If you choose to renew this license, you **MUST** do so before that expiration date.
