pay the amount of seventeen cents (\$0.17) per square foot per month to the City, in accordance with the rates and regulations outlined in the Port Code and Port Tariff Code.

The premises may be occupied and used solely for the purpose of storage of equipment. It is understood and agreed that User shall not erect any structure on the premises without the expressed written consent of the Port of Homer. User expressly releases the City from any obligation to protect the subject property from vandalism, theft, or other similar occurrences, and agrees to hold the City harmless from any claims that may arise from the use thereof.

There shall be no right or option to renew this agreement, or to reassign the same in whole or in part.

**TERMINATION.** At the termination of this agreement, User shall vacate the subject premises, leaving the same in as good condition as existed at the time of initial occupancy, and User further agrees to reimburse the City for any expenses the City may incur for cleanup of the premises necessitated by the use under this agreement.

Either party may terminate this agreement by the giving of not less than five (5) days written notice to the other, specifying the date of termination. Delivery of the notice shall be considered completed upon receipt by the respective parties. User understands that payments made in advance for the premises shall be reimbursed for the unused portion if City terminates this agreement.

Tenancy beyond the termination date shall not be allowed without the expressed, written consent of the Port of Homer. Items not removed from the premises within twenty-four (24) hours of the date of termination will be impounded and are subject to sale at a public auction.

The City may terminate this agreement for a higher and/or better use; such higher and/or better use to be determined solely by the Homer City Council.

The undersigned hereby agrees, as part of the consideration for rental of storage space, to comply with all ordinances, rules, regulations, and policies governing use of the port and harbor facilities and further agrees to waive all claims against the city. To hold the city harmless from any and all claims of whatever kind arising out of movement by the city of equipment owned or operated by the undersigned, whether such movement is due to emergency or delinquent storage rental. Undersigned further agrees to immediately notify the port of homer upon removal of gear to discontinue billing.
